**1. CALL TO ORDER / ROLL CALL**

**3. APPROVAL OF MINUTES**

**4. Chair Report**

Dr. Jenkusky reported that he and Ms. Frank attended the New Mexico Medical Society Annual meeting.

Dr. Jenkusky also reported that he and Ms. Frank will be having lunch with Randy Marshall and the New Mexico Medical Society on September 28, 2018 to discuss artificial intelligence and algorithmic medical prescribing.

**5. Consider In Person Appearance By Respondents At Evidentiary Hearing.**

**MOTION** was made by Dr. Jenkusky to adopt a declaratory ruling providing:

At evidentiary hearings, respondents and fact witnesses must appear in-person *unless* (1) the opposing party agrees otherwise and/or (2) circumstances beyond the control of the respondent or fact witness precludes an in-person appearance. Circumstances beyond the control of the respondent or fact witness include incarceration, military orders, physical or mental incapacity, and unanticipated weather or similar conditions. Inconvenience, scheduling conflicts, difficulty in making travel arrangements, and other circumstances that might be considered as voluntary would not be considered as being beyond the control of the respondent or fact witness. In cases where a person cannot appear in person, the respondent or fact witness may appear electronically, but only if the party requesting the electronic appearance provides written, advance assurance to the Board in advance of the hearing that the electronic appearance will not interfere with the conduct of the hearing or result in increased expense to the Board. **SECONDED** by Dr. Spence. **YES:** Dr. Jenkusky, Dr. Spence, Dr. Styka, Mr. Dunlap, Dr. Beaudette, Dr. Carson and PA Otero. **ABSENT:** Dr. Komadina and Ms. Anderson. **MOTION CARRIED.**

### **Complaint Committee A**

**Case #2016-A-289; 2017-A-098; 2017-A-305 RECOMMENDATION** was made by Dr. Beaudette offering physician a stipulated license requiring her to participate in education through CPEP in medical recordkeeping, chronic pain management, ethics and patient communications, along with payment of a fine in the amount of \$4000 plus expert costs. If she does not accept, a notice of contemplated action will be issued based on, but not limited to, repeated negligent acts, injudicious prescribing, and failure to maintain accurate, complete medical records, conduct unbecoming and failure to follow the Board's regulation on PMP use. **YES:** Dr. Jenkusky, Dr. Spence, Dr. Styka, Mr. Dunlap and PA Otero. **RECUSED:** Dr. Beaudette, Dr. Carson **ABSENT:** Dr. Komadina and Ms. Anderson. **MOTION CARRIED.**

**Case #2018-A-005 RECOMMENDATION** was made by Dr. Beaudette offering physician the chance to either (1) voluntarily surrender her license or (2) enter into an interim stipulation of licensure requiring no practice until cleared to return to work by physician's treating physician and the Board along with a notice of contemplated action based on, but not limited to, failure to report adverse action on clinical privileges, failure to comply with the Board's Regulation on Chronic Opiate Use, misrepresentation on renewal applications, manifest incapacity to practice, and conduct likely to harm. If physician does not accept either option, a summary suspension will be issued based on imminent danger to the public, along with a notice of contemplated action based on above. **YES:** Dr. Jenkusky, Dr. Spence, Dr. Styka, Mr. Dunlap and PA Otero. **RECUSED:** Dr. Beaudette, Dr. Carson **ABSENT:** Dr. Komadina and Ms. Anderson. **MOTION CARRIED.**
