**Natalie Pavelock, MD** – **MD2017-0011** – Notice of Amendment to Notice of Contemplated Action was issued based on unprofessional or dishonorable conduct; Habitual or excessive use of intoxicants; conduct likely to deceive, defraud or harm the public; failure to furnish the Board, its investigators representatives with information requested by the Board and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. (March 2021)
