

BOARD ACTIONS

(Actions taken between October 1, 2018 through December 31, 2018)

Ferial Abood, MD – 2002-0001 – Agreed Order for Stipulation on Licensure was issued requiring that Dr. Abood pay fines in the amount of \$4,000.00; reimburse the Board \$2,250.00 for costs incurred; successfully complete educational courses in medical record keeping, chronic pain management, ethics and patient communications at CPEP. This action is based on a pattern of negligent conduct, engaging in injudicious prescribing, failure to maintain accurate, complete medical records, conduct unbecoming and failure to comply with Board Rule governing the management of pain and other conditions with controlled substance. Ferial Abood, MD – 2002-0001 – Order Denying Respondent's Motion for Reconsideration of Imposition of Fees. (November 2018)

Heather Carriedo, MD – MD2015-0582 – Notice of Contemplated Action was issued based on habitual or excessive use of intoxicants or drugs; misrepresentation in applying for or procuring a license to practice in New Mexico or in connection with applying for or procuring renewal; manifest incapacity or incompetence to practice as a licensee; conduct likely to harm the public; conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. (October 2018)

Heather Carriedo, MD – MD2015-0582 – Agreed Interim Order for Inactivation of License and Stipulation Requiring Clearance and Approval before License Can Be Issued based on habitual or excessive use of intoxicants or drugs; misrepresentation in applying for or procuring a license to practice in New Mexico or in connection with applying for or procuring renewal; manifest incapacity or incompetence to practice as a licensee; conduct likely to harm the public; conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. (October 2018)

Heather Carriedo, MD – MD2015-0582 – Agreed Order Imposing Stipulations on License was issued precluding Dr. Carriedo from applying to reinstate her license until she provides satisfactory evidence that she is able and competent to practice medicine; she prohibited from practicing medicine in New Mexico until the Board approves her to do so, which may include the imposition of requirements restrictions and conditions on her license and she is required to pay fines totaling \$2,000.00 within 90 days of the agreed order. (December 2018)

Stephen Coleman, MD – 95-209 - Stipulation of Licensure issued mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the license. (November 2018)

Frank Durso, MD – 80-142 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (November 2018)

Steven Greer, MD – MD2017-0872 – Notice of Contemplated Action was issued based on habitual or excessive use of alcohol; the use of a false, fraudulent or deceptive

statement in a document connected with the practice of a licensee; failure to furnish the board, its investigators or representatives with information requested by the Board; conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. (October 2018)

Siavash Karimian, MD – MD2007-0234 – Notice of Contemplated Action was issued based on injudicious prescribing; failure to report a health condition that could affect patient care or safety; failure to comply with the NMMB's Pain Management rule; failure to maintain complete and accurate medical records; failure to cooperate with an NMMB subpoena for medical records; providing misleading testimony in an appearance before the NMMB in another matter and conduct unbecoming. (December 2018)

Austin Oetken, MD – RS2018-0923 – Stipulation of Licensure issued mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the license. (November 2018)

Charles J. O'Hearn, MD – Applicant – Notice of Contemplated Action was issued based on unprofessional or dishonorable conduct; misrepresentations in applying for a license; engaging in conduct likely to deceive, defraud or harm the public; discipline by another licensing entity; failing to furnish the Board with requested information; engaging in conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public and dishonesty. Dr. O'Hearn violated the AMA Code of Medical Ethics; failed to satisfy the Board's post graduate training requirements; failed to disclose underlying facts of multiple arrests; failure to fully and accurately disclose the details of investigations and disciplinary actions taken by the Texas Medical Board. Failure to report conduct resulting in legal proceedings involving Dr. O'Hearn's practice of medicine including CMS's revocation of the CLIA of one or more emergency care facilities owned by him. Engaged in conduct that could disrupt and/or adversely affect patient care and unduly confrontational when defending his personal interests to the detriment of the community at large. (November 2018)

Bishnu Rauth, MD – 91-288 – Order for Reimbursement of Costs was issued in the amount of \$78,646.91. (November 2018)

Mark Standley, PA – PA2018-0080 – Stipulation of Licensure was issued requiring that Mr. Standley abstain completely from the use of mind-altering substances, alcoholic beverages, or controlled substances except as legitimately prescribed; he must remain in a treatment contract with New Mexico Health and Wellness Program.
