Erich Arias, MD – MD2016-0790 – Administrative Order of Release from Stipulation. Licensee has a full and unrestricted license. (November 2020)

Steven Black, MD - MD2011-0547 - Agreed Order Imposing Reprimand, Fines and Stipulation was issued requiring Dr. Black accept a formal reprimand and pay fines totaling \$2000.00 within 60 days following entry of this agreed order; mandating that Dr. Black abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program within 30 days following entry of this order. This is not considered a restriction on the license. Norman Neil Brown, MD –Applicant– Agreed Order Accepting Respondent's Voluntary Withdrawal of Initial Application for License While Under Investigation was issued based on the best interest of Dr. Brown, the Board, and the public. (October 2020)

Luis Cisneros, MD – MD2016-0786 - Agreed Order Imposing Reprimand, Fines

and Stipulation was issued requiring Dr. Cisneros accept a formal reprimand and pay fines totaling \$1000.00 within 60 days; Dr. Cisneros also is mandating that to abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program within 30 days following entry of this order. This is not considered a restriction on the license. This action is based on habitual or excessive use of intoxicants or drugs; failure to report to the Board any adverse action taken against the licensee by a health care entity or law enforcement agency for acts or conduct similar to act or conduct that would constitute grounds for action and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. David Durham, MD- MD2008-0595 - Agreed Order Imposing Reprimand, Fines and Stipulation of License was issued requiring that Dr. Durham accept a formal reprimand and pay a fine of \$5000.00 within four months following entry of this order (November 20, 2020). In one or more instances, and with respect to one or more patients, Dr. Durham did not comply with the Board's rule governing the management of pain and other conditions with controlled substances. Dr. Durham's testimony to the Board regarding the frequency with which he reviewed PMP reports prior to issuing controlled substance prescriptions lacked support in prescription monitoring program (PMP) reports maintained by the New Mexico Board of Pharmacy. Dr. Durham did not maintain timely and accurate medical records with respect to one or more patients he was treating with controlled substances. Dr. Durham did not respond to Board requests for records regarding his treatment of one or more patients and was not forthcoming regarding his own medical treatments. Dr. Durham did not adhere to standard security measures for protecting prescription pads and did not comply with requirements regarding issuing prescriptions based on his practice locations. In Case No. 2012-032, the Board previously disciplined Dr. Durham in connection with his prescribing of controlled substances and his failure to maintain timely and accurate medical records. Dr. Durham unnecessarily and inappropriately involved himself in the court proceedings of a personal acquaintance. (November 2020)
