

BOARD ACTIONS

(Actions taken between July 1, 2022 through September 30, 2022)

Terry Hansen, M.D. – MD2015-0101 – Agreed Order for Stipulation on License mandating that Dr. Hansen abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the License. (July 2022)

Richard A. Wolf, M.D. – MD2022-1033 - Agreed Order for Stipulation of License mandating that Dr. Wolf abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with the NM Health Professional Wellness Program. This is not considered a restriction on the License. (July 2022)

David A. Richardson, M.D. - Applicant – Agreed Order for Stipulation of License mandating that Dr. Richardson abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the Respondent's practice. (July 2022)

Morgan L. Day, M.D. – Applicant – Agreed Order for Stipulation of License mandating that Dr. Day abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the Respondent's practice. (July 2022)

Gordon H. Lee, Resident M.D. – Applicant – Agreed Order for Stipulation of License mandating that Dr. Lee abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the Respondent's practice. (July 2022)

Paul Engstrom, M.D. – MD2000-181 – Agreed Order mandating the payment of a \$1,000.00 fine and the issuance of a public reprimand based on the Respondent's failure to comply with the NM Public Health Order during the pandemic. (August 2022)

Vijay P. Agarwal, M.D. – MD2022-1252 – Agreed Order Imposing Stipulations on License mandating a probationary period on Dr. Agarwal’s medical license for a period of two years commencing on the effective date of this Order. Respondent must enroll and successfully complete the “Probe” ethics program, “Medical Record Keeping” course and the “Improving Inter-Professional Communications” course at CPEP within six months with submission of all course material to Board for review upon completion.

James Cain, M.D. – Applicant – Agreed Order Accepting Respondent’s Voluntary Withdrawal of Initial Application for License While Under Investigation was issued on the best interest of Dr. Cain, the Board and the public. (August 2022)

Stephen Cain, M.D. – MD2010-0224 – Agreed Order mandating the payment of a \$2,000.00 fine with an agreed upon payment plan of \$100.00 per month and the issuance of a public reprimand based on the doctor’s failure to maintain complete, timely and accurate medical records on a patient. (August 2022)

Jasmine Breitung, M.D. – MD2005-0825 – Agreed Order Imposing Stipulations on License mandating that Dr. Breitung enroll and successfully complete the Controlled Substances Prescribing course and enroll in and successfully complete the Medical Record Keeping Course at CPEP within three (3) months from the date of Order (September 1, 2022) based on injudicious prescribing and failing to maintain complete and legible medical records. (Sept. 2022)

Eugenio Castillo, M.D. – 87-351 – Agreed Order Imposing Stipulations on License mandating that Dr. Castillo participate in a clinical skills assessment at the Center for Personalized Education for Professionals (CPEP) within six (6) months of the effective date of this Order (Sept. 2022).

Eric Y. Peterson, M.D. – 95-322 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (Sept. 2022)
