Anita M. Roybal, M.D. – MD84-110 – Decision and Order Revoking License based upon the unlicensed practice of medicine, conduct likely to harm the public. Failure to furnish the Board, it's investigators or representatives with information requested by the Board and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. Stephanie Tingling, P.A. – **Applicant** – Decision and Order Denying License based on misrepresentations in the application for licensure and for failure to respond to information requested by the Board. (January 2023)

Anjmun Sharma, M.D. – **MD2018-0656** - Agreed Order Imposing Stipulations on License mandating the issuance of a letter of reprimand and a permanent voluntary medical marijuana prescribing restriction for violation of the New Mexico Medical Practice Act and Board Regulations. (January 2023)

Kenneth Stoller, M.D. – **97-382** – Decision and Order Revoking License based upon unprofessional and dishonorable conduct. Discipline imposed on a licensee by another state, including denial, probation, suspension or revocation. Gross negligence in the practice of a licensee. Manifest incapacity or incompetence to practice as a licensee. Repeated similar negligent acts. Conduct likely to deceive, defraud or harm the public. Conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. Violation of Board Regulation and a lack of an appropriate physician-patient relationship. William Summers, M.D. – **93-406** – Notice of Contemplated Action issued based on respondent's failure to follow Department of Health mask mandate requirements, conduct likely to harm the public and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. Notice of Contemplated Action issued based on respondent's conduct likely to harm the public, conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. Theresa Smith de Cherif, MD – **MD2008-0396** - Letter of Reprimand was issued based on a Reprimand issued against the Respondent by the New Hampshire Board of Medicine. This action is based on a physician-patient boundary issue that could constitute a violation under the Board's Regulations and the New Mexico MPA. (February 2023)

Timothy Bray, D.O. – **A-1953-16** – Agreed Order imposing Stipulations on License based on the respondent's violation of the MPA by making false statements in a document connected with the practice of medicine; engaging in conduct likely to deceive, defraud or harm the public, failure to report to the Board the adverse action, and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public, and ethical violations. (February 2023)

Jon Fowler, D.O – **R-179-2021** - Order of Release issued stating that the stipulations placed on Respondent's license to practice medicine are hereby removed and Respondent shall have an unrestricted license to practice medicine in New Mexico. (February 2023)

Malathy Sundaram, M.D. – **Applicant** – Decision and Order Denying License based on multiple recent adverse licensure actions against respondent. The adverse actions stemmed from concerns about respondent's clinical skills competency and non-compliance with other state Board Orders concerning practice monitoring and recommendations. Respondent engaged in conduct contemplated by the Medical Practice Act's non-excusive definition of "unprofessional or dishonorable conduct". (March 2023) La Tania Akers-White, M.D. – MD2020-0735 – Agreed Order for Voluntary Surrender of License While Under Investigation based on adverse actions taken by several states including Virginia. The adverse action taken in Virginia was based on prescribing controlled substances to patients without documenting the appropriate exams, history, diagnosis and treatment plans for doing so; prescribing controlled substances to patients without seeing them, and violating federal laws for dispensing controlled substances. Respondent failed to report the adverse licensure actions to the Board as required by the Medical Practice Act and Board Regulation. Respondent failed to respond to Board investigators during the Board investigators during the Board's investigation of these matters. (March 2023)

Katherine Bo Lee, M.D. – MD2015-0912 – Agreed Order for Voluntary Surrender of License While Under Investigation based on conduct inconsistent with the ethical and professional practice of medicine. Adverse licensure action in another start based on negligence, gross negligence, unprofessional conduct and failure to maintain adequate medical records. Respondent failed to report this adverse licensure action to the Board as required by the Medical Practice Act. (March 2023)

Peter K. Tiernan, M.D. – **MD2006-0119** - Notice of Contemplated Action issued based on respondent's interactions with others that could adversely affect patient care. (March 2023)

Shawn Alan Smith, P.A. -PA2010-0018 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (March 2023)
