Respondent has not clinically practiced since 2007 and is not licensed to practice in any other state. Respondent engaged in conduct contemplated by the Medical Practice Act's non-exclusive definition of "unprofessional or dishonorable conduct". (April 2023)

**Sterling Williams, M.D.** – Agreed Order for Stipulation on License mandating that respondent sign a mandatory treatment and participation contract with the NM Health Professional Wellness Program. To abstain completely from the use of all mind-altering substances, alcoholic beverages, and controlled substances. This is not considered a restriction on the license. (April 2023)

**Joseph Cohn, M.D.**– Agreed Order for Stipulation on License mandating that respondent sign a mandatory treatment and participation contract with the NM Health Professional Wellness Program. Failure to furnish the board, its investigations or representatives with information requested by the board, see, e.g., NMSA 1978, § 61-6-15 (D)(23). Interaction with physicians, hospital personnel, patients, family members or other that interferes with patient care or could reasonably be expected to adversely impact the quality of care rendered to a patient, see, e.g., NMSA 1978, § 61-6-15 (D)(36). **Stephen Rath- MD2008-0112** Order of Release from Stipulation. Licensee has a full and unrestricted license. (May 2023)

**Leah Becker, PA 2000-PA11-** Order of Release from Stipulation. Licensee has a full and unrestricted license. (May 2023)
