BOARD ACTIONS

Brian Bererian, MD – MD2017-0787 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (May 2018)

Steven Black, **MD** – **MD2011-0547** – Decision and Order issued by the Board lifting Dr. Blacks's license suspension based on lack of evidence presented at hearing that Dr. Black poses a clear and immediate danger to the public. (April 2018)

Paul Bolger, MD – MD2014-0960 – Agreed Order for Voluntary Surrender of License was issued based on Dr. Bolger's guilty plea on August 22, 2017 to eighteen counts of false statements relating to health care matters and five counts of introduction of misbranded drugs. (June 2018)

Neil Bourjaily, P.A. – **Applicant** – Agreed Order Accepting Respondent's Voluntary Withdrawal of Initial Application While under Investigation based on misrepresentation on an application for licensure; conduct unbecoming; failure to furnish the Board with information; making a false or deceptive statement in a document connected with the practice of medicine; and conduct likely to harm. (April 2018)

John Bray-Morris, **MD** – **2003-0404** – Agreed Order for Voluntary Surrender of License barring Dr. Bray-Morris' ability to practice medicine in New Mexico and waiving any right he may have to apply for reactivation, reinstatement, or issuance of a new license to practice medicine if he fails to present evidence satisfactory to the Board of his complete and continuous sobriety during the eighteen month period following entry of this order. Further, Dr. Bray-Morris must reimburse the Board for its costs of investigating his case in the amount of \$7,500.00. This action is based on the Amended Notice of Contemplated Action issued to Dr. Bray-Morris on July 14, 2017. (July 2018)

Ericka Charley, MD – RS2017-0447 - Stipulation of Licensure issued mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the license. (May 2018)

Charles Cooley, MD – Applicant – Agreed Order Accepting Respondent's Voluntary Withdrawal of Initial Application While under Investigation based on habitual or excessive use of substances, adverse action taken against him by another state medical board and incompetency to practice. (June 2018)

Erika Garbrecht, MD – MD2018-0306 - Stipulation of Licensure transferred from Resident License to full MD License mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must remain in a treatment contract with NM Health Professional Wellness Program for monitoring of substance abuse. This is not considered a restriction on the license. (May 2018)

Edwin B. Hall, MD - 75-161 - Agreed Order for Voluntary Surrender of License

While Under Investigation based on injudicious prescribing resulting in 6 patient deaths as a result of an overdose; failure to adequately access the Prescription Monitoring Program database as mandated per Board Rule; failure to maintain adequate medical and billing records; practicing without a license by signing applications for medical cannabis after his license was summarily suspended and aiding and abetting the unlicensed practice of medicine. (April 2018)

Dominique Hill, MD – Applicant – Notice of Contemplated Action was issued based on not meeting the requirements for licensure in NM by not completing the USMLE within the required seven years; misrepresentation on her application for a medical license and dishonesty in her interactions with the Board. (May 2018)

Robert Jarczak, PA – Applicant – Agreed Order Accepting Respondent's Voluntary Withdrawal of Initial Application While under Investigation was issued based on misrepresentation on his application for licensure, conduct unbecoming and dishonesty. (June 2018)

Padmaneel Kanase, MD – 2001-50 – Decision, Order of Reprimand and Stipulation on License was issued based on conduct likely to deceive, defraud or harm the public; repeated similar negligent acts; and failure to adequately supervise a medical assistant who renders health care. Dr. Kanase shall successfully complete the "Practical Medical Ethics and Professionalism" course administered by Western Institute of Legal Medicine; pay a \$1,000.00 fine within three months of the order; and reimburse the Board its costs within three months of the order. (May 2018)

Lynda Labranche, **MD** – **RS2015-0571** – Agreed Order to Resolve Case was issued. It was agreed that Dr. Labranche would voluntarily surrender her license while under investigation based on unprofessional conduct, failure to maintain medical records and dismissal from her residency program. (May 2018)

Patricia Lacy, PA - Stipulation of Licensure issued mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the license. (May 2018)

Pavel Mourachov, MD – MD2008-0654 – Agreed Order For Voluntary Surrender Of License was issued based on lack of compliance with May 2013 order to have a neuropsychological evaluation and complete a CPEP Skills Assessment. (June 2018)

Deborah Parr, MD – MD2013-0058 – Order of Reprimand and Stipulations on License was issued requiring that Dr. Parr obtain a clinical skills assessment by CPEP within six months of the order specific to addiction treatment; complete a medical records course through CPEP within six month of the order and reimburse the Board \$550.00 for costs incurred during investigation. This action is based on injudicious prescribing, failure to maintain proper medical records and engaging in a pattern of conduct unbecoming to a member of the profession. (June 2018)

Neil Pivar, MD – 81-288 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (May 2018)

Thomas Prose, MD – 2003-0453 – Order Denying Respondent's Request for Stay was issued because the public interest is not served by staying the proceedings. (April 2018)

Curtis Quintana, PA – PA2003-0032 - Stipulation of Licensure issued mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Health Professional Wellness Program. This is not considered a restriction on the license. (May 2018)

Daniel Rowland, MD – MD2016-0286 – Order of Reprimand and Stipulation on License requiring that Dr. Rowland pay a \$150.00 investigative fee if he seeks to reactivate his license to practice medicine in New Mexico. This action is based on failure to report adverse action taken against his license by the Arizona Medical Board. (June 2018)

Sidney Sanford, AA – **Applicant** – Order of Reprimand and Stipulation on License requiring that applicant pay a \$500.00 fine that will be administratively released upon payment of the fine. This action is based on misrepresentation on her application, dishonesty to law enforcement and Board investigators. (April 2018)

Walter Seidel, MD - 94-351 – Default Order Revoking Dr. Seidel's License. This action is based on Dr. Seidel's failure to request a hearing and the unrebutted allegations contained in the NCA issued 2/15/18. (May 2018)

Walter Seidel, MD - 94-351 – Amended Decision and Order affirming the decision of the Board entered on November 2, 2017, and ordering that the respondent is fine \$1,000.00 per violation of the Medical Practice Act for a total of \$2,000.00 which shall be paid within ninety days of entry of the order. Additionally respondent shall pay the costs of the proceedings. (May 2018)

Timothy Trapp, MD – MD2004-0055 – Order of Reprimand issued based on inappropriately accessing a Prescription Monitoring Program record for an individual who was not a patient of his. (May 2018)
