Bryant, Frank, MD – License No. 85-147 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (November 2015)

Carroll, Leslie, MD – License No. MD2006-0503 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (November 2015)

Greer, Kyle, MD – License No. RS2015-0928 - Stipulation of Licensure mandating that the physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. This is not considered a restriction on the license. (December 2015).

Heilbron, Roy, MD – License No. MD2006-0145 - Order of Immediate Suspension due to imminent danger to the public. Simultaneously, a Notice of Contemplated Action was issued based on, but not limited to, incompetency to practice, failure to maintain adequate medical records, and conduct unbecoming. (November 2015)

Hempstead, Richard, MD – License No. 77-181 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (December 2015)

Hutsinpillar, Molly, MD – License No. MD2015-0897 - Stipulation of Licensure mandating that the physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. This is not considered a restriction on the license. (November 2015).

Lewis, Randall, PA – License No. PA2008-0018 – Order of the Board to revoke NM Physician Assistant license based on adverse licensure action in another state and failure to report adverse licensure action in another state. (November 2015)

Lietzke, Christina, MD – License No. MD2014-0021 –A notice of contemplated action was issued based on, but not limited to, impairment, licensure action in another state, failure to report, misrepresentation on a renewal application, and failure to cooperate. NCA Issued October 14, 2015.

Luchini, Marianne, MD – License No. 2002-0335 – Order of the Board to revoke NM Medical Doctor License based on conduct likely to harm, failure to

furnish the Board with information requested by the Board, conduct unbecoming, and improper management of medical records. (November 2015)

Miller, Clyde, MD – License No. MD2007-0136 – Summarily suspended until further order of the Board. Simultaneously, a Notice of Contemplated Action was issued to Dr. Miller based on, but not limited to, injudicious prescribing, failure to maintain medical records, making a false statement in a document connected to the practice of medicine (forging scripts), impairment, violation of a drug law and failure to comply with licensing requirements. (December 2015)

Overlie, Paul, MD – License No. 94-114 – Order of the Board reprimanding Dr. Overlie for violating the Medical Practice Act by failing to report other board action. A Stipulation of Licensure was issued that Dr. Overlie must comply with any instructions or recommendation made by CPEP. (November 2015)

Rizo-Patron, Carlos, MD – License No. 2003-0613 – Notice of Contemplated Action issued based on failure to report his Texas Licensure Action to the NMMB. (November 2015)

Sheikh, Shafeeq, MD – License No. MD2014-0969 – Order of Immediate Suspension based on physician being an imminent danger to the public. Simultaneously, a Notice of Contemplated Action will be issued based on, but not limited to, conduct likely to harm, conduct unbecoming, adverse licensure action taken by another medical board, misrepresentation in applying for initial licensure and licensure renewal, and possible conviction of a crime. (November 2015)

Sica, Robban Ariel, MD – Stipulation and Order for Withdrawal of Initial Application – Based on the NMMB's initial application investigation the NMMB and Dr. Sica determined that it would be in the best interest of the public to allow Dr. Sica to withdraw her initial application in lieu of issuance of a Notice of Contemplated Action and other formal proceedings. (December 2015)

Van Osten, Kathleen, MD – License No. 91-133 - Stipulation of Licensure mandating that the physicians license remain on Inactive status and abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. This is not considered a restriction on the license. (October 2015).

Van Osten, Kathleen, MD – License No. 91-133 - Stipulation of Licensure allowing physicians license to be re-activated and mandating that physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. This is not considered a restriction on the license. (December 2015).

Van Wormer, Mark, MD – License No. MD2015-0906 – Based on prior revocation of licensure in New Mexico the NMMB issued a Stipulation of Licensure and Order that Dr. Van Wormer be required to practice medicine under the observation of a worksite monitor at each worksite and hospital, the worksite monitor will provide the Board with affidavits attesting to Dr. Van Wormer's compliance. Dr. Van Wormer is prohibited from having any role in evaluating, managing, diagnosing or treating aesthetic or cosmetic dermatologic conditions. (November 2015).
