

BOARD ACTIONS

(Actions taken between July 1, 2014 through September 30, 2014)

Anderson, Ramona M.D. - License No. MD2007-0794 - Issued Stipulation of Licensure requiring physician's license to remain suspended until cleared to return to practice by physician's treating physicians and has completed an independent neuropsychological evaluation as well as clearance from her treating pain specialist. (August 2014)

Bray-Morris, John M.D. - License No. 2003-0404 - Issued Order reinstating the prescriptive authority to prescribe controlled substances to physician. All other terms and conditions of physician's stipulation of licensure remain in effect. (August 2014)

Bryant, Frank M.D. - License No. 85-147 - Issued Notice of Contemplated Action based on incompetency to practice; misrepresentation on a renewal application; discipline taken against physician by another state medical board; and failure to report adverse action to the board. (August 2014)

Casebolt, Donald M.D. - License No. 91-15 - Issued Stipulation and Order allowing physician to place his license on inactive status while under investigation pending competency assessment by a third party. (September 2014)

De Stefano, Paul M.D. - License No. 98-39 - Issued Order of the Board lifting the Interim Stipulation of Licensure. Physician may prescribe controlled substances. All other terms and conditions set forth in the June 2014 Stipulated Order remain in effect. (August 2014)

Gomez, Gregory MD - Applicant - Decision and Order issued denying application for medical licensure based on adverse licensure action taken by another state and conduct unbecoming. (August 2014)

Greer, Steven M.D. - License No. RS2014-0607 - Issued Stipulation of Licensure requiring mandatory participation in the NM Monitored Treatment Program based on habitual or excessive use of alcohol or substances. No restrictions on physician's practice of medicine. (July 2014)

Hansen, Ralph M.D. - License No. MD2009-0071 - Issued Order of Release from Stipulation of Licensure. Physician has an active unrestricted license to practice medicine in New Mexico. (August 2014)

Heaphy, Kathleen P.A. - License No. PA2007-0017 - Issued Stipulation of Licensure restricting PA from prescribing opioids or providing any treatment to any patient for chronic pain management. (September 2014)

Heilbron, Roy M.D. - License No. MD2006-0145 - License restored 09-24-14. Physician has met all terms and conditions set forth in his Stipulation of Licensure and Order from June 2014. (September 2014)

Heldzinger, Derek M.D. - License No. MD2012-0645 - Decision and Order of Board

determining that physician's license shall not be reinstated, but physician may reapply for reinstatement of licensure only after he receives a full and unrestricted license to practice in Georgia. This action was based on adverse licensure action taken against physician in another state and failure to report to the Board the adverse action taken. (July 2014)

Hewett, Bernie M.D. - License No. 69-146 - Issued Default Revocation Order revoking the medical license of physician based on injudicious prescribing; failure to maintain medical records and conduct likely to harm. Physician did not request hearing. (August 2014)

Jones, Christopher M.D. - License No. MD2012-0775 - Issued Order of Release from Stipulation of Licensure. Physician has an active unrestricted license to practice medicine in New Mexico. (August 2014)

Khan, Ali M.D. - Applicant for Licensure - Issued Notice of Contemplated Action to deny licensure based on adverse licensure action in another state; conduct unbecoming; conviction of an offense; the use of a deceptive statement in a document associated with the practice; injudicious prescribing; repeated similar negligent acts; and misrepresentation in applying for licensure. (August 2014)

Khan, Ali M.D. - Applicant for Licensure - Stipulated Order allowing physician to withdraw his application for licensure in lieu of a hearing. (September 2014)

Kothalanka, Sitaramakrishna M.D. - License No. MD2007-0129 - Issued Order revoking the medical license of physician based on incompetency; the use of a false, deceptive or fraudulent statement in a document connected with the practice of medicine; failure to report adverse action; failure to maintain accurate and complete medical records. (August 2014)

Krell, Douglas M.D. - License No. 82-234 - Issued Stipulation of Licensure and Order reprimanding physician for failure to report adverse action taken by a healthcare entity and law enforcement agency and required to complete the ProBE Ethics Course offered by CPEP within 6 months based on violation of physician's October 2007 Stipulation. (September 2014)

May, Darrick M.D. - License No. MD2014-0608 - Issued Order of Release from Stipulation of Licensure. Physician has an active unrestricted license to practice medicine in New Mexico. (August 2014)

Milne, Robert M.D. - License No. 81-270 - Stipulation and Order requiring physician to place license on inactive status while under investigation pending an assessment by a third party based on possible conduct likely to harm. (September 2014)

Mitchell, Roderick M.D. - License No. 83-82 - Issued Decision and Order of Board suspending physician's license to practice medicine in New Mexico pending the resolution of his licensure appeal in the State of Texas. (August 2014)

Nardacci, Nicholas MD - License No. 80-72 - Issued Order of the Board Return to Work Restrictions. Physician may return to work doing immigration and social security examinations only; physician shall enroll in MTP for the purpose of being monitored for

use of controlled substances for chronic pain and UDS; physician is subject to periodic independent psych evaluations and/or group counseling as determined by the Board; physician's patient charts shall be reviewed on a quarterly basis. (August 2014)

Sanchez, Milton PSGT - License No. PT2014-0014 - Issued Stipulation of Licensure requiring mandatory participation in the NM Monitored Treatment Program; quarterly appearances in front of board; and quarterly compliance affidavits. (August 2014)

Spruce, Haruhuani, M.D. - License No. 2002-0475 - Notice of Contemplated Action issued based on repeated similar negligent acts, injudicious prescribing, failure to maintain timely, accurate and complete medical records and excessive prescribing or administering of drugs. (September 2014)

Stoller, Kenneth M.D. - License No. 97-382 - Issued Notice of Contemplated Action based on conduct likely to harm; gross negligence; use of a false, fraudulent or deceptive statement in a document connected with the practice of a licensee; improper management of medical records; injudicious prescribing. (August 2014)

Van Osten, Kathleen - License No. 91-133 - Issued Order of Release from formal Stipulation of Licensure. Physician has an active unrestricted license to practice medicine in New Mexico. (August 2014)

Walden, Mark M.D. - License No. MD2007-0765 - Order of the Board revoking the medical license of physician, but staying the revocation. Physician's license remains on suspended status. Within one year, Physician shall obtain a complete history and physical examination and obtain a neuropsychological evaluation in accordance with the results of his competency evaluation report by CPEP. Once those are complete and reviewed by the Board, the Board will make further licensure determinations. (August 2014)

Watts, Richard M.D. - License No. 63-85 - Retired license while under investigation based on allegations of injudicious prescribing. (September 2014)
