**Bennett, Charles M.D.** – License No. 2015-0588 - Stipulation of Licensure mandating that the physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. (August 2015)

**Butler, Christopher M.D. – Applicant** – Stipulation Agreement whereby physician withdrew his application for physician licensure. (July 2015)

**Cain, Stephen M.D.** – License No. MD2010-0224 – Amended Stipulation of Licensure to allow physician to return to non-anesthesia related practice as approved by The New Mexico Monitored Treatment Program (MTP) and have MTP approve physician’s worksite prior to return. (August 2015)

**Casebolt, Donald M.D.** – License No. 91-15 – Order to allow licensee to surrender his license in lieu of meeting the terms and conditions contained in his stipulation and order dated 9/2/2014. (August 2015)

**Choudry, Yasin M.D.** – License No. MD2015-0665 – Stipulation of Licensure mandating that the physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract with NM Monitored Treatment Program. (August 2015)

**Fisher, Ronald M.D. – Applicant** – Issuance of a Notice of Contemplated Action to deny licensure based on misrepresentation on application, habitual or excessive use of substances, sexual contact with a patient, incompetency to practice, conduct likely to harm. (July 2015)

**Gelinas, Claude M.D.** – License No. 97-245 – Stipulation of Licensure and Order to surrender his license in lieu of disciplinary proceedings. (August 2015)

**Guttman, Stuart M.D. – Applicant** – Issuance of a Notice of Contemplated Action to deny licensure based on incompetency to practice. (July 2015)

**Hussain, Shabbar M.D. – Applicant** – Stipulation Agreement whereby physician withdrew his application for physician licensure. (July 2015)

**Jaikaran, Jacques M.D. – Applicant** – Issuance of a Notice of Contemplated Action to deny licensure based on conviction, misrepresentation in application for licensure, incompetency to practice, adverse licensure action in another state, and conduct unbecoming. (July 2015)

**Levitt, Keith M.D.** – License No. MD2012-0646 - Order of Release from Stipulation. Licensee has a full and unrestricted license. (August 2015)

**Lewis, Randall, P.A.** – License No. PA2008-0018 – Issuance of a Notice of Contemplated Action against Mr. Lewis' license up to and including revocation, based on the North Carolina Medical Board's revocation of license due to sexual misconduct.

**Lundgren, Alston M.D.** – License No. 98-323 – Decision and Order of immediate license suspension. The Board will consider lifting the suspension once Dr. Lundgren has obtained a neurological assessment by a Board approved neurologist, obtained a neuropsychological evaluation by a Board approved neuropsychologist and participate in a structured individualized educational intervention in identified areas of need. (August 2015)

**Pritchard Yanke, Traci M.D.** – License No. TM2012-0107 - Stipulation of Licensure mandating that the physician abstain from the use of mind-altering substances, alcohol and non-prescribed controlled substances and must enter into a treatment contract NM Monitored Treatment Program. Dr. Pritchard Yanke was also issued a letter of reprimand for failing to self-report an adverse action.

**Sachsel, Nancy P.A.** – License No. PA2011-0055 – Order of Immediate Suspension and Notice of Contemplated Action based on violation of Board ordered stipulation. (August 2015)

**Sanchez, Milton, Polysomnographic Technologist** – License No. PT2014-0014 – Order of Release from Stipulation. Licensee has a full and unrestricted license. (August 2015)

**Spruce, Haruhvani M.D.** – License No. 2002-0475 – Order to allow licensee to surrender her license in lieu of continuing with the disciplinary mandates contained in her stipulation of licensure dated 6/2/2015. (August 2015)

**Stoller, Kenneth M.D.** – License No. 97-382 – Advisory Letter based on failure to provide medical records with regard to a child abuse investigation. Licensee was also ordered to pay costs. (August 2015)

**Van Eeckhout, Barbara, M.D.** – License No. 2002-302 – Stipulation of Licensure and Order to notify each patient and insurance company of their right to reimbursement for any charges in connection with the non-FDA approved intrauterine device by 12/15/2015. To pay a fine of \$17,000.00 to the Board by 7/1/2016. Enroll in and complete CPEP/Professionalism Problem Based Ethics and Boundaries course by 7/1/2016. (August 2015)
