Steven Black, MD – **MD2011-0547** – Notice and Order of Summary Suspension was issued based on evidence indicating that Dr. Black poses a clear and immediate danger to the public health and safety if he continues to practice; Dr. Black is being treated for chronic pain with opiates since January 2016 without undergoing an independent neuropsychological evaluation and having received clearance from his treating physician to continue to practice as required by the NMMB. (February 2018)

Steven Black, MD – MD2011-0547 – Notice of Contemplated Action was issued based on evidence indicating that Dr. Black poses a clear and immediate danger to the public health and safety if he continues to practice; Dr. Black is being treated for chronic pain with opiates since January 2016 without undergoing an independent neuropsychological evaluation and having received clearance from his treating physician to continue to practice as required by the NMMB. (February 2018) **Claud Brachfeld, MD** – **MD2004-0709** – Stipulated Order for Voluntary Surrender of License based on disciplinary action in another state, unprofessional or dishonorable conduct, failure to report disciplinary action in another state and conduct unbecoming in a person licensed to practice or detrimental to the best interests of the public. Walter Seidel, MD – 94-351 – Notice and Order of Summary Suspension was issued based on evidence indicating that Dr. Seidel poses a clear and immediate danger to the public health and safety if he continues to practice; failure to request prescription monitoring program reports from the Board of Pharmacy when prescribing controlled substances; prescribing an opioid, a benzodiazepine and carisoprodol, sometimes referred to as "the holy trinity" to patients despite substantial evidence that this combination of medications has led to many overdose deaths; and prescribing quantities and combinations of controlled substances that present a danger to the public health. (February 2018)
