Aswad, Mohamed M.D. - License No. 2003-0043 - Issuance of an Immediate Summary Suspension based on physician being an immediate danger to the public health and safety and pleading guilty to an offense related to the practice of medicine. (November 2014)

Aswad, Mohamed M.D. - License No. 2003-0043 - Issuance of a Notice of Contemplated Action based on obtaining a fee by fraud, making false or misleading statements regarding the efficacy or value of the treatment administered by the licensee, gross negligence, use of a false statement in a document connected with the practice of medicine, conduct likely to deceive, defraud or harm the public, repeated similar negligent acts, conviction of a misdemeanor within the practice of medicine. Ayon, Dennis M.D. - Applicant - Issuance of a Notice of Contemplated Action based on conduct unbecoming, conviction of an offense punishable by incarceration or conviction of a misdemeanor associated with the practice of medicine, use of a false statement in a document connected with the practice of medicine, misrepresentation in applying for a license, habitual or excessive use of alcohol, conduct likely to harm. (October 2014)

Carroll, Leslie M.D. - License No. MD2006-0503 - Stipulation of Licensure issued requiring mandatory participation in the NM Monitored Treatment Program. (December 2014)

Driskill, Christopher M.D. - License No. 2003-0585 - Issuance of an Immediate Summary Suspension based on physician being an immediate danger to the public health and safety. (November 2014)

Driskill, Christopher M.D. - License No. 2003-0585 - Issuance of a Notice of Contemplated Action based on sexual contact with a patient, habitual or excessive use of alcohol or substances, conduct likely to harm the public, failure to report adverse action to the Board, injudicious prescribing, conduct unbecoming, failure to maintain accurate medical records and interaction with others that could adversely impact the quality of care rendered to a patient. (November 2014)

Lieberman, Richard M.D. - License No. 76-218 - Order of Release from Stipulation issued by Board. Physician has an unrestricted license to practice medicine in NM. (November 2014)

Martin, Louis M.D. - Applicant - Issuance of a Notice of Contemplated Action based on licensure action in another state, repeated similar negligent acts, and manifest incompetence to practice. (November 2014)

Nardacci, Nicholas M.D. - License No. 80-72 - Amended Decision and Order issued

removing the term “fraud” from the Board’s original Decision and Order. (November 2014)

Sarrai, Mona M.D. - License No. 2014-056 - Stipulation of Licensure issued requiring mandatory participation in the NM Monitored Treatment Program. (December 2014)

Shrader, Welman M.D. - License No. 91-308 - Stipulation of Licensure issued requiring mandatory participation in the NM Monitored Treatment Program (December 2014)

Spruce, Haruhuani Cecilia M.D. - License No. 2002-0475 - Stipulated Order issued prohibiting physician from prescribing any controlled substances, or supervising or directing any healthcare provider to prescribe controlled substances to physician’s patients; requiring physician to submit to a competency assessment in chronic pain management at CPEP within six months. (November 2014)

Stake, Benjamin M.D. - License No. 93-160 - Issuance of an Order allowing physician to return to work with restrictions and continued stipulation requiring MTP participation. (November 2014)

Walden, Mark M.D. - License No. MD2007-0765 - Issuance of an Order granting prosecution’s request for respondent to pay costs in the amount of \$4,853.17. (November 2014)

Walden, Mark M.D. - License No. MD2007-0765 - Order of the Board reconfirming revocation of license with the revocation stayed and license remaining suspended and ordering physician to complete a full residency program within two years prior to requesting reinstatement of licensure. (November 2014)

Walsky, Paul M.D. - License No. 78-283 - Stipulation of Licensure requiring mandatory participation in the NM Monitored Treatment Program for ongoing psychotherapy and work site monitoring. (December 2014)
