**BOARD ACTIONS**

April 1, 2015 through June 30, 2015

**Arrington, Alan M.D.** – License No. MD2007-0573 – Letter of Reprimand issued based on prescribing controlled substances without maintaining proper medical records; required additional CME hours in prescribing controlled substances. (June 2015)

**Aswad, Mohamed, M.D.** – License No. 2003-0043 – Issuance of Decision and Order of the Board formally reprimanding physician based on conduct likely to harm; conviction of a misdemeanor within the practice of medicine; violation of a drug law; and practicing medicine without an active license. (May 2015)

**Bryant, Frank M.D.** – License No. 85-147 – Settlement Agreement entered into between physician and Board whereby physician accepts a formal letter of reprimand for his failure to report adverse licensure action taken by another state medical board, and agreed to a clinical skills assessment based on length of time out of practice in U.S. License remains on inactive status until assessment report is received. (May 2015)

**Charlie, Jimmie M.D.**- License No. 2002-0019 – Order releasing physician from Stipulation of Licensure. Physician has an unrestricted license to practice medicine in NM. (May 2015)

**Garcia, Jose M.D.** – License No. MD2005-0658 – Issuance of a Stipulation of Licensure and Order reprimanding physician based on conduct unbecoming and restricting physician's license to prohibit him from performing, or supervising anyone who performs, pelvic ultrasound exams on any pregnant patient and cannot offer or provide any prenatal care and treatment to any patient. (May 2015)

**Kamermans, Rob M.D.** – License No. 93-294 – Order Amending Stipulation and Order to lift the preceptorship condition. All other terms and conditions from January 2015 Stipulation of Licensure remain in effect. (May 2015)

**Mahan-Riska, Kaaren P.A.** – License No. PA2004-0011 – Issuance of a Stipulation of Licensure requiring mandatory participation in the NM Monitored Treatment Program, which is not a restriction on the license of physician assistant; reprimanded for prescribing controlled substances to a family member without maintaining medical records. (June 2015)

**May, Andre M.D.** – License No. MD2012-0565 – Issuance of a Stipulated Order whereby physician agrees to permanently place NM license to practice on

inactive status and agrees to never reapply for reinstatement of that license in NM. Based on licensure action in another state and failure to report. (May 2015)

**Moretti, Adrian Resident M.D.** – License No. RS2015-0296 – Issuance of a Stipulation of Licensure requiring mandatory participation in NM Monitored Treatment Program. This is not a restriction on the license of resident physician. (June 2015)

**Schaefer, Stefan M.D.** – License No. 97-365 – Issuance of a formal letter of reprimand based on obtaining a fee by misrepresentation. (May 2015)

**Spruce, Haruhuani Cecilia M.D.** – License No. 2002-0475 – Order Amending Stipulation and Order placing additional terms on medical license of physician based on a clinical competency evaluation. Physician is still restricted from prescribing controlled substances. (June 2015)

**Stoller, Kenneth, M.D.** – License No. 97-382 – Issuance of an Amended Notice of Contemplated Action. (April 2015)
