#### Financial / HR Manager

Ms. Mascarenas reported to the Board the following:

#### FY19 Budget/Revenue Status ending June 30, 2019.

From July 1, 2018 through June 30, 2019 expenditures total \$1,906,817 (or 93.99%) of budgeted expenditures (Opbud \$2,028,700);

From July 1, 2018 through June 30, 2019 the agency collected revenues in the amount of **\$2,121,703** (or 108.88%) of budgeted revenues of **\$1,948,700**. In FY19 the agency also budgeted \$80,000 fund balance which may be utilized toward the end of the fiscal year if expenditures exceed the budgeted revenues.

The audited Fund Balance on June 30, 2018 is **\$1,151,939**. The cash balance as of June 30, 2019 is **\$1,440,551**. The June 30, 2019 audited Fund Balance will be available after the FY19 Audit has been completed and will be reported at the next regular board meeting.

Ms. Mascarenas also provided the Board the FY19 Statistics Summary that reflects the application/renewal and other fees that makes up the total revenues collected in FY19 beginning on July 1, 2018 through June 30, 2019 in the amount of \$2,121,703.

Further, Ms. Mascarenas reported the FY21 Appropriation Request is due to DFA and LFC by September 3, 2019 and will be working on the FY21 Appropriation Request next week that will include 2-3 new positions: State Investigator, Attorney and a Paralegal.

# NMHA – Letter to the New Mexico Medical Board Regarding Peer Review

Ms. Frank presented a letter to the Board from David Johnson regarding clarification of the Board's position regarding types of peer review constitute the practice of medicine in New Mexico. #### 18. Patrick Hudson, MD Presentation on Coaching Services.

Dr. Hudson presented to the Board his coaching services for physicians, he provides services for physicians only. All coaching is one-on-one, physician to physician. Coaching usually begins with an intervention lasting several hours and is tailored to the needs of the individual institution or physician. Dr. Hudson feels very strongly that his initial contact with

physicians need to involve the development of trust, so that the physician knows that coaching will benefit him or her, as well as an organization.

The recommended approach includes one or two days of intense coaching, maximum of 5 hours coaching per day. During this time, Dr. Hudson will get to know the physician and lay out the program for the next few weeks. After the initial intervention it is recommended that the average physician 10-12 weekly live or telephone sessions each lasting about 50 minutes. All clients need a DiSC evaluation (which is an assessment to determine personality style) prior to the coaching and as needed other evaluations might be needed, including EQ (emotional intelligence assessment) and/or 360s (assessment helps identify strengths and developmental needs).

In closing Dr. Hudson stated that it is very unlikely a lifetime pattern of poor communication, anger or poor emotional intelligence will change quickly. After the conclusion of the sessions monthly telephone follow-up sessions for one year are recommended.
