1. CALL TO ORDER / ROLL CALL

4. Chair Report

Dr. Jenkusky reported that he, Ms. Frank, Ms. Dieterich and Ms. Quintana had a meeting with William Brady, MD, who is a NMHPWP Board Member to discuss the issues that the New Mexico Medical Board is having with NMHPWP. Dr. Jenkusky reported that Dr. Brady will be doing assessments for the New Mexico Medical Board in the interim.

5. Executive Director

Ms. Frank reported that on Friday, September 27, 2019 the Naturopathic Advisory Committee is going to meet with staff to continue working on the rules for licensure of Naturopathic Doctors. Ms. Quintana

is preparing the Visiting Sports Physician rules, Ms. Frank also reported that the PA prescribing rule is completed.

The Board returned to open session. Dr. Jenkusky stated for the record that the matters discussed in executive session were limited only to those specified in the motion for closure.

6. ACTIONS RELATED TO EXECUTIVE SESSION

Complaint Committee A

Case #2019-A-189 RECOMMENDATION was made by Dr. Beaudette to offer physician applicant a stipulated license requiring payment of \$1000 fine along with the issuance of a reprimand, and payment of \$1500 in costs for the PPQs answered incorrectly on all Board applications. If physician applicant does not accept, he may withdraw his application for licensure while under investigation or a Notice of Contemplated Action will be issued to deny licensure based on, but not limited to, dishonesty, misrepresentations on multiple applications and failure to report adverse action as required. YES: Dr. Jenkusky, Dr. Spence, Dr. Unverzagt, Ms. Saavedra, PA Otero, Dr. Anderson and Dr. Carson. RECUSED: Dr. Beaudette. ABSENT: Ms. Anderson. MOTION CARRIED.

Case #2019-A-196 RECOMMENDATION was made by Dr. Beaudette to issue an unrestricted medical license with payment of \$450 in administrative costs for incorrect PPQ answers on application and an advisory letter reminding physician about full disclosure in an application for licensure. Case #2019-B-145 RECOMMENDATION was made by Dr. Jenkusky to issue a Notice of Contemplated Action based on, but not limited to, injudicious prescribing and repeated similar negligent acts contingent upon a finding following expert review, but also giving prosecutor flexibility to combine this case with the pending prosecution case against physician. If physician applicant does not accept, he may withdraw his application for licensure while under investigation or a notice of contemplated action will be issued based on, but not limited to, habitual and excessive use of alcohol or substances and adverse licensure action in another state. YES: Dr. Beaudette, Dr. Spence, Dr. Unverzagt, Ms. Saavedra, PA Otero and Dr. Carson. RECUSED: Dr. Jenkusky and Dr. Anderson. ABSENT: Ms. Anderson. MOTION CARRIED.

Case #2019-B-219 RECOMMENDATION was made by Dr. Jenkusky to offer physician a stipulation of licensure that allows for increased monitoring of physician by Board in order to ensure compliance. Specifically, physician shall return to and comply with the initial NMHPWP contract requirements that have been lifted or decreased by NMHPWP and submit all required documentation to NMHPWP and

the Board. In addition, physician shall comply with any biological testing as mandated by the Board. Physician shall also comply with all recommendation made by Bradford; shall be restricted from prescribing amphetamines; and shall pay a fine of \$1000. If physician does not accept, a Notice of Contemplated Action will be issued based on, but not limited to, violation of a board stipulation, dishonesty and conduct unbecoming. **YES:** Dr. Beaudette, Dr. Spence, Dr. Unverzagt, Ms. Saavedra, PA Otero and Dr. Carson. **RECUSED:** Dr. Jenkusky and Dr. Anderson. **ABSENT:** Ms. Anderson. **MOTION CARRIED.**
