FY19 Budget/Revenue Status

Ms. Mascarenas reported the FY19 Budget/Revenue Status ending January 31, 2019.

- ✓ From July 1, 2018 through January 31, 2019 expenditures total \$1,068,100 (or 52.65%) of budgeted expenditures (Opbud \$2,028,700);
- From July 1, 2018 through January 31, 2019 the agency collected revenues in the amount of \$439,962 (or 22.58%) of budgeted revenues of \$1,948,700. In FY19 the agency also budgeted \$80,000 fund balance which may be utilized toward the end of the fiscal year if expenditures exceed the budgeted revenues.
- ✓ The audited Fund Balance on June 30, 2018 is \$1,151,939. The cash balance as of today is
