Ms. Mascarenas reported that her and Ms. Frank attended the HAFC subcommittee hearing on January 14, 2020, in which the HAFC approved the LFC recommendation (7.2% less or \$180.0) from the amount requested by the agency. On February 18, 2020 the HAFC Adopted Substitute for HB2, 2020 General Appropriations Act which includes \$2,330.0, funding for one (1) new position in FY21, and additional BAR authority language of \$100,000.

## FY20 Budget/Revenue Status

Ms. Mascarenas reported the FY20 Budget/Revenue Status ending January 31, 2020. The Budget and Revenue Status ending January 31, 2020 are as follows:

- ✓ From July 1, 2019 through January 31, 2020 expenditures total \$1,165,372 (or 53.97%) of budgeted expenditures (Opbud \$2,159,300).
- ✓ From July 1, 2019 through January 31, 2020 the agency collected revenues in the amount of \$585,898 (or 27.13%) of budgeted revenues of \$2,159,300.
- ✓ The Fund Balance on June 30, 2019 is *\$1,342,981*. The cash balance as of February 19, 2020 is *\$798,332*.

Ms. Mascarenas reported to the Board the FY20 Statistics Summary that reflects the application/renewal and other fees that makes up the total revenues collected in FY20 beginning on 7/1/19 through 1/31/20 in the amount of \$585,898.

# **Executive Director Report**

## **Closure of Service Complaints.**

Ms. Frank asked the Board about the possibility of closing out certain "service complaints" at staff level. However, there is no issue with a NM licensed peer reviewer to consult with out of state, non-NM licensed physicians as consultants as long as it was infrequent and the final decision on the peer review came from the NM licensed Physician.
