FY21 Financial Audit

- The FY21 Financial Audit was conducted the week of October 4-22, 2021.
- The exit audit conference was held on October 26, 2021. In attendance, via zoom, were Thad Porch (the auditor), Dr. Beaudette, Executive Director, Frank and Ms. Mascarenas.
- The audit has not been released by the State Auditor’s office at this time.
- At the next interim or regular board meeting the Audit Firm, Porch & Associates, LLC (Thad Porch) who conducted the Financial Audit will present the FY21 audit to the board. The Board will need to vote to approve the audit at that time.

FY22 Budget/Revenue Status

- Report the FY22 Budget/Revenue Status ending September 30, 2021.
The Budget and Revenue Status ending September 30, 2021 are as follows:
 - ✓ From July 1, 2021 through September 30, 2021 expenditures total **\$468,086 (or 18.39%)** of budgeted expenditures (Opbud \$2,545,100);
 - ✓ From July 1, 2021 through September 30, 2021 the agency collected revenues in the amount of **\$329,775 (or 13.1%)** of budgeted revenues of **\$2,515,100 (\$30,000 FB budgeted in FY22)**.
 - ✓ The Fund Balance on June 30, 2021 is **\$2,336,745**. The cash balance as of November 2, 2021 is **\$2,078,112**.
- For your reference you received the FY22 Statistics Summary that reflects the application/renewal and other fees that makes up the total revenues collected in FY22 beginning on 7/1/21 through 9/30/2021 in the amount of \$329,775.

13. Old Business


Dr. Unverzagt proposed that the Board recognize physicians making a difference in New Mexico by recognizing them at Board meetings and sending them positive letters.
