C. Executive Director

Ms. Frank reminded the board about the retreat on Friday, March 4, 2022.

D. Finance

Ms. Mascarenas provided the board with the portions of HAFC, Substitute for HB2 that pertain to the NMMB's FY23 Operating Budget for their reference. Once Governor Lujan Grisham signs HB2, the NMMB's FY23 Operating Budget will include \$2,700.0 (p. 53-54) (6% increase from FY22) plus the FY22 Compensation appropriation (starting on p. 216) which is based on HB2 and calculated by the Department of Finance & Administration (DFA).

Under Section 7. Information Technology Appropriations (p. 209), item 14, HB2 includes \$1,311.2 for the continuation of the implementation of the licensing software upgrade. To date, the agency has budgeted \$500.0 appropriated in FY22 and has spent \$86,062.68 through March 1, 2022 for Program Manager and IV&V services (this includes \$16,127.31 of our regular appropriation). DFA has not approved the last C2 funding budget request for this appropriation (submitted to DFA in January, 2022) in the amount of \$316,000.

Ms. Mascarenas also provided the board an update on FY22 Budget/Revenue Status

The Budget and Revenue Status ending January 31, 2022 are as follows:

- ✓ From July 1, 2021 through January 31, 2022 expenditures total **\$1,183,228 (or 46.49%)** of budgeted expenditures (Opbud \$2,545,100);
- ✓ From July 1, 2021 through January 31, 2022 the agency collected revenues in the amount of **\$623,214 (or 24.8%)** of budgeted revenues of **\$2,515,100** (\$30,000 FB budgeted in FY22). (\$650,608 collected last fiscal year for the same period)
- ✓ The Fund Balance on June 30, 2021 is **\$2,336,745**. The cash balance as of March 1, 2022 is **\$1,705,347** (last year at this time the cash balance was \$1,227,063).

Also provided for reference is the FY22 Statistics Summary that reflects the application/renewal and other fees that makes up the total revenues collected in FY22 beginning on 7/1/21 through 1/31/2022 in the amount of \$623,214.

##### **Review and consider approval of rules for rule hearing in June of 2022:**

##### **16.10.2 NMAC – Physicians: Licensure Requirements:**

Ms. Griego presented to the board the proposed rule change that would allow any Foreign Medical Graduate that is ECFMG certified to apply for a license and that will be the only requirement that will be looked at in lieu of the Foreign Medical School evaluation or being on the California Medical Board approved list. The board had a brief discussion. **MOTION** was made by Dr. Spence to approve changes to 16.10.2 NMAC as presented by Ms. Griego. **SECONDED** by Dr. Anderson **YES:** Dr. Beaudette, Dr. Unverzagt, Ms. Johnson, Dr. Reidy, Dr. Spence, Dr. Carson, Dr. Anderson, Dr. Jenkusky, Ms. Saavedra and Dr. Scoggins. **MOTION CARRIED.**

Ms. Quintana presented to the board the proposed addition of a temporary license type for traveling sports team physicians. The board had a brief discussion.

Dr. Jenkusky informed the Board that he has been renominated to be on the Governors Overdose Prevention and Pain Management Advisory Council.


