- A. At all times relevant to this proceeding, the Board has had jurisdiction over Respondent and the subject matter, continuity that the record closed on June 11, 2021.

- B. In its proceedings, the Board accorded Respondent all the due process to which she is entitled.
- C. A preponderance of the evidence supports the following factual allegations.
  - 1. Concerns within the Respondent's practice group regarding Respondent's well being and safety of patients which resulted in Respondent being assessed by the New Mexico Health Professional and Wellness program (HPWP) on two occasions.
  - 2. Respondent engaged in conduct that reflects poorly on the profession and can affect patient safety.
  - 3. Respondent was not forthcoming to the Board investigators regarding her conduct.
  - 4. Respondent failed to provide the New Mexico Health and Wellness program (HPWP) with documentation they requested for purposes of assuring her ability to practice in a safe and competent manner.
- D. Respondent's conduct, as established by a preponderance of the evidence, constitutes, contemplated by the nonexclusive definition of "unprofessional and dishonorable" conduct, as defined in Section 61-6-15(D) of the Medical Practice Act and the Board's Rules.
  - 1. "Habitual or excessive use of intoxicants or drugs" NMSA 1978, § 61-6-17(D)(7),
  - 2. "Conduct likely to deceive, defraud or harm the public" NMSA 1978, § 61-6- 15(D)(18),
  - 3. "Failure to furnish the Board, its investigators or representatives with information requested by the Board" NMSA 1978, § 61-6- 15(D)(23),
  - 4. "Conduct unbecoming in a person licensed to practice of detrimental to the best interest of the public" NMSA 1978, § 61-6- 15(D)(29),
- E. Respondent's violation of the Medical Practice or the Boards rules subjects respondent to discipline including imposition of fines and or remedial requirements. NMSA 1978, § 61-1-4(A).
- F. No basis exists for the Board to excuse Respondent from reimbursing the Board the costs it incurred in its proceedings against her. NMSA 1978, § 61-1-4(G).

#### **FY21 Budget/Revenue Status**

- Report the FY21 Budget/Revenue Status ending June 30, 2021.  
The Budget and Revenue Status ending June 30, 2021 are as follows:
  - ✓ From July 1, 2020 through June 30, 2021 expenditures total **\$1,977,490 (or 84.62%)** of budgeted expenditures (Opbud \$2,336,900);
  - ✓ From July 1, 2020 through June 30, 2021 the agency collected revenues in the amount of **\$2,596,632 (or 121.5% )** of budgeted revenues of **\$2,136,900. (In FY20 the agency collected \$2,423,564) = \$173,068 higher this year.**

- ✓ The Fund Balance on June 30, 2020, is **\$1,717,603**. The cash balance as of June 30, 2021, is **\$2,445,840**.

**\*Note this amount will be reduced by \$500,000 in FY22 to be utilized for the NMMB Licensing Software Modernization in the current fiscal year leaving a balance of \$1,945,840.**

- For your reference you received the FY21 Statistics Summary that reflects the application/renewal and other fees that make up the total revenues collected in FY21 beginning on July 1, 2020, through June 30, 2021 in the amount of \$2,596,632.
