The Board directs Natalie Pavelock, MD to contact NMHPWP by Friday, September 30, 2022, at 5pm MST, to comply with all provisions of the Decision and Order which includes signing a mandatory participation agreement with the NMHPWP program; comply with all HPWP monitoring requirements and sign and maintain any and all releases necessary for participation in the NMHPWP program. The Board will allow Natalie Pavelock, MD a second and final opportunity to comply with the Decision and Order by the end of the period of suspension or Friday, September 30, 2022, at 5pm MST. If Natalie Pavelock, MD fails to comply with the Decision and Order during the stated period of suspension by Friday, September 30, 2022, by 5pm MST, the Board orders the license of Natalie Pavelock, MD to be revoked.

Ms. Mascarenes reported to the Board, the following items.

**FY22 Budget/Revenue Status**

- Report the FY22 Budget/Revenue Status ending June 30, 2022.



The Budget and Revenue Status ending June 30, 2022 are as follows:

- ✓ From July 1, 2021 through June 30, 2022 expenditures total **\$2,189,039 (or 86%)** of budgeted expenditures (Opbud \$2,552,200).
- ✓ From July 1, 2021 through June 30, 2022 the agency collected revenues in the amount of **\$2,810,639 (or 111.4%)** of budgeted revenues of **\$2,522,200 (\$30,000 FB budgeted in FY22)**. (Last FY the agency collected \$2,596,632 in revenues. The increase from FY21 to FY22 is 8.2% or \$214,000 increase in revenues collected in FY22). The increase was primarily in application fees from \$420,885 collected in FY21 to \$588,475 collected in FY22 – 39.8% increase or \$167,590 more revenues collected in FY22).
- ✓ The Fund Balance on June 30, 2021 is **\$2,336,745**. The cash balance as of June 30, 2022 is **\$3,377,596 (last year at this time the cash balance was \$2,445,840)**.

**The Statistics Summary for FY22 is provided for the board’s information**

**IT Appropriation – Licensing Database**

- The IT Multi-year appropriation for the Licensing Database budgeted in FY22 is \$1,811,200 utilizing fund balance. As of September 2, 2022, the agency expended \$396,867 and encumbered (committed) \$710,170 of the appropriation for a total of \$1,107,037 expended and encumbered. You can see the detailed expenses and encumbrances by vendor provided to you on the status report.

**Approve FY24 Appropriation Request**

- The agency is requesting 17.24% increase in the FY24 Appropriation Request compared to the FY23 Operating Budget. Additional funds in the 300 (contractual services) and 400 (other/operating costs) categories are primarily to address recurring costs for licensing and maintenance of the new Licensing Database. In FY22 and FY23 the agency requested and received approval through the C2 request process for the “NMMB Licensing Software Modernization”. The appropriation request also includes an increase in contractual services to assist NMMB staff during the transition of the licensing database upgrade and additional funds for hearing officers, attorney services and an increase to the NMMP contract. The Appropriation Request also includes a 2% vacancy rate (in comparison to the FY23 Operating Budget) in salaries and benefits.
