### B. Chair Report

### C. Medical Director

- Medical Spa Update – Dr. Jenkusky reported to the Board that he has been working with the Nursing Board and Pharmacy Board on a joint policy about Medical Spa’s. Dr. Jenkusky has been doing research about other state rules around Medical Spa’s and proper supervision of medical assistants. One resource he stated that has been very helpful is The American Spa Association which outlines what procedures are able to be performed at medical spas by state. The Board discussed other Possible future Board policies and research related to IV Clinics. The Board will create a committee to put together an information packet for future discussion with the Board regarding Med Spa rules and regulations.

-Hospital Association Annual Meeting & Medical Society Annual Meeting – The Board has been invited to do a presentation for both the New Mexico Hospital Association Annual Meeting and the Medical Society Annual Meeting. Dr. Jenkusky, Amanda Quintana and Monique Parks will present at the meetings together on behalf of the Board.

-FSMB: Policies - **Self Prescribing and Changing Specialties** – Dr. Jenkusky presented the two policies drafted by FSMB. The Board discussed the process for issuing future Policy statements and adding them to the Boards website.

#### **D. Licensing Manager**

Monique Parks, Licensing Manager spoke briefly about the following subjects:

- HSC: Application Processing Status - In May of 2022 the Board approved the rule to require all physicians to utilize the HSC (Hospital Services Corporation). They have taken over providing primary verifications, that would otherwise land on the physician to provide. This includes professional recommendations, work verifications, medical education verifications as well as all PGT verifications. We understand how busy most physicians are, and this has most definitely helped make the application process more efficient, streamlined and overall faster. We have issued 1,819 Physicians licenses compared to last year's 1,563- we continue to see this increase yearly.
- Salesforce (New System Update) – As you know, we went live April 21st with our new online database. We have had some bumps in the road. Each day we continue to learn what may have been an efficient and or effective way of processing applications, and our day-to-day tasks may not be the best way now that we are fully online. Staff is constantly updating the system making changes that benefit the applicant/licensee and the general public. We have received positive feedback, as in a license automatically being renewed if no red flags, public license search updated in real time and that they can print an unofficial license at any time.
- 2023 Renewal Status – We had 4,625 licensee’s that were up for renewal. This included MD, DO, RS, AA and DN (Naprpaths). As of today, we have had 4,205 renew.

#### **E. Finance**

Ms. Mascarenas reported to the Board the following items.

##### **FY23 Budget/Revenue Status**

- Report the FY23 Budget/Revenue Status ending June 30, 2023.

The Budget and Revenue Status ending June 30, 2023 are as follows:

- ✓ From July 1, 2022 through June 30, 2023 expenditures total **\$2,585,000 (or 92.96%)** of budgeted expenditures (Opbud \$2,780,700);
- ✓ From July 1, 2022 through June 30, 2023 the agency collected revenues in the amount of **\$2,944,900 (or 114.1% )** of budgeted revenues of **\$2,580,700. (In FY22 the agency collected \$2,810,600) = \$134,274 higher this year.**
- ✓ The Fund Balance on June 30, 2022 is **\$3,137,607**. The cash balance as of June 30, 2023 is **\$2,715,066**.

**(In summary, the Board maintains a healthy fund balance and revenue stream.)**

- For your reference the Board received the FY23 Statistics Summary that reflects the application/renewal and other fees that makes up the total revenues collected in FY23 beginning on July 1, 2022 through June 30, 2023 in the amount of \$2,944,900.

### **FY21-FY24 IT Appropriation – Licensing Database Status**

- Report the FY21-FY24 IT Funding via Fund Balance Status ending July 31, 2023. The IT Multi-Year appropriation for the Licensing Database budgeted in FY22 utilizing fund balance ending July 31, 2023 are as follows:
  - ✓ Laws of 21, 1S C137-S7-I008
    - \$500,000 was budgeted in FY22 (Appropriation end date is 6/30/2023 – fully expended)
  - ✓ Laws of 22, 2S, C54-S7-I014
    - \$1,311,200 was budgeted in FY22 (Appropriation end date is 6/30/2024)
    - Total expenditures through July 31, 2023 \$746,200 and \$340,000 encumbered for Operations & Maintenance agreement with Kyra Solutions, leaving a balance of \$224,900 in the appropriation, which can only be utilized for this project.
