FY23 Budget/Revenue Status

- Report the FY23 Budget/Revenue Status ending June 30, 2023.
The Budget and Revenue Status ending June 30, 2023 are as follows:
 - ✓ From July 1, 2022 through June 30, 2023 expenditures total **\$1,385,241 (or 49%)** of budgeted expenditures (Opbud \$2,780,700).
 - ✓ From July 1, 2022 through June 30, 2023 the agency collected revenues in the amount of **\$668,200 (or 25.8%)** of budgeted revenues of **\$2,580,700**.
 - ✓ The Fund Balance on June 30, 2022 is **\$200,000**. The cash balance as of June 30, 2023 is **\$2,780,700**.

IT Appropriation – Licensing Database

- The IT Multi-year appropriation for the Licensing Database budgeted in FY22 is \$1,811,200 utilizing fund balance. As of January 31, 2023 the agency expended \$745,289 and encumbered (committed) \$443,884 of the appropriation for a total of \$1,189,173 expended and encumbered.

- 1) To remove impairment question 15.
- 2) To add “In the last five years, have you been mandatorily enrolled in a Physician Health Program or similar monitoring program or have you been told that to maintain your license you must enroll in a PHP?”
- 3) To add this statement: The New Mexico Medical Board encourages all applicants and licensees to properly care for their physical and behavioral health needs, for both their own wellbeing and that of their patients. The independent New Mexico Health Professional Wellness Program is available to provide assistance on a confidential, voluntary basis (<http://nmhpwp.com>).
- 4) consider changing heading for this section to remove the word "impairment" possibly make it Ethics/Health?
