Case # 2017-A-001 Recommendation was made by Dr. Jenkusky to offer physician an agreed order requiring inactivation of his medical license during the term of incarceration and allowing him to apply for reinstatement of his medical license and granting licensure with the following stipulations: (1) Issuance of a Reprimand; (2) permanent prohibition from prescribing compound medications to patients; (3) requiring successful completion of an ethics course through CPEP or comparable program; and (4) requiring a practice monitor for an indefinite period of time. If physician does not accept, physician's license will be summarily suspended based on pleading guilty to an offense related to the practice of medicine and a notice of contemplated action will be issued based on, but not limited to, conviction of an offense within the practice of medicine, conduct unbecoming, conduct likely to deceive the public and ethical violations. **YES:** Dr. Beaudette, Dr. Carson, Dr. Spence, Dr. Anderson, Dr. Unverzagt, PA Johnson and Dr. Scoggins. **RECUSED:** Dr. Jenkusky and Dr. Reidy. **EXCUSED:** Ms. Saavedra. **MOTION CARRIED.**

The Board took a moment to review the proposed changes.


