1 CHAIR BEAUDETTE: This hearing will please come to

- 2 order. I am Peter Beaudette, Chairman of the New Mexico
- 3 Medical Board. I'll be acting as the Presiding Officer for
- 4 this Rule Hearing.
- 5 The purpose of this hearing is for the Board to
- 6 receive public comment on the proposed rule changes to
- 7 16.10.2; 16.10.3; 16.10.4; 16.10.5; 16.10.9; 16.10.10;
- 8 16.10.11; 16.10.14; 16.10.15; 16.6.3; 16.6.5; 16.6.7; 16.6.8
- 9 and 16.6.9.
- 10 As a general summary, the proposed changes to 16.10
- 11 involve changes to the term allopathic physicians to
- 12 physicians so that both allopathic doctors, MDs, and doctors
- 13 of osteopathy, DOs, are incorporated into the rule. The
- 14 proposed rule adds osteopathic physician credentials and
- 15 licensure requirements and adds the definition of physician,
- 16 which means allopathic doctor or doctor of osteopathy.
- 17 As additional proposed changes is to add to the New
- 18 Mexico Medical Board's licensing requirements a list specific
- 19 criminal convictions that would -- did we skip one --
- 20 disqualify an applicant from receiving a license based on
- 21 previous felony conviction.
- 22 Sondra, do you want me just to go through that? Do
- 23 we make any comments as we go through this now, or not?
- 24 EXECUTIVE DIRECTOR FRANK: No, we're just giving an
- 25 overview about --

- 1 CHAIR BEAUDETTE: An overview, okay.
- 2 EXECUTIVE DIRECTOR FRANK: And if you need help
- 3 reading through these, would you let us know. But we do need
- 4 to read through them line by line.
- 5 CHAIR BEAUDETTE: Right, okay.
- 6 EXECUTIVE DIRECTOR FRANK: And just so the record is
- 7 clear, the numbers are 16.10.3. They're not dash, but you
- 8 need to read each point, just so the record is super clear.
- 9 CHAIR BEAUDETTE: Right.
- 10 16.10.3 is Examinations. As a general summary, the
- 11 proposed changes to 16.10.3 again changes the reference from
- 12 allopathic physician to physicians and adds the required
- 13 exams for osteopathic medical licensing.
- 14 16.10.4 concerns Continuing Medical Education. As a
- 15 general summary, the proposed changes to 16.10.4 adds the
- 16 required continuing medical education for osteopathic medical
- 17 licensing.
- 18 16.10.5, as a general summary, the proposed changes
- 19 to 16.10.5 is to update the rule to add more relevant
- 20 language and take out obsolete processes.
- 21 16.10.9, as a general summary, the proposed changes
- 22 to 16.10.9 is to make grammatical changes to errors in the
- 23 rule.
- 24 16.10.10 is the Reporting of Settlements, Judgments,
- 25 Adverse Actions and Credentialing Discrepancies. As a

1 general summary, the proposed change is to add locum tenens

- 2 or staffing agencies to the definition of health care entity.
- 3 16.10.11 Physicians Supervising Pharmacist
- 4 Clinicians. As a general summary, the proposed changes are
- 5 to update the rule language with current practice and
- 6 licensing processes and requirements.
- 7 16.10.14 Management of Pain and Other Conditions
- 8 with Controlled Substances. As a general summary, the
- 9 proposed changes to 16.10.14 changes the term medical doctor
- 10 to physician.
- 11 16.15 Physician Assistants: Licensure and Practice
- 12 Requirements. As a general summary, the proposed changes to
- 13 16.10.15 changes the term medical doctor to physicians.
- 14 And my computer has frozen here. Sondra, do you
- 15 have -- for some reason I'm -- my computer has now refused to
- 16 go any further.
- 17 EXECUTIVE DIRECTOR FRANK: Do you want me to
- 18 continue reading for you?
- 19 CHAIR BEAUDETTE: I've got it. I've got it, okay.
- 20 16.10.15, Physicians Assistants: Licensure and
- 21 Practice Requirements. As a general summary, the proposed
- 22 changes to 16.10.15 changes the term medical doctor to
- 23 physician. I'm sorry, we said that.
- 24 16.6.3. As a general summary, the proposed changes
- 25 to 16.6.3 lower fees for naturopathic practitioner licensing

1 to align with the fees for other mid-level providers licensed

- 2 by the New Mexico Medical Board.
- 3 EXECUTIVE DIRECTOR FRANK: This is naprapathic --
- 4 CHAIR BEAUDETTE: Naprapathic.
- 5 EXECUTIVE DIRECTOR FRANK: -- providers.
- 6 Naprapathic.
- 7 CHAIR BEAUDETTE: Naprapathic with a P, yes. I'm
- 8 sorry.
- 9 16.6.5 Inactive Status, Reinstatement. As a general
- 10 summary, the proposed changes to 16.6.5 allow for a
- 11 naprapathic practitioner to inactivate their license with a
- 12 one-time fee of \$25 as opposed to \$100 per year.
- 13 16.6.7 Licensure by Endorsement and Examination. As
- 14 a general summary, the proposed changes to 16.6.7 combines
- 15 the requirements for naprapathic practitioner licensing by
- 16 endorsement and by examination. The requirements are similar
- 17 and did not need to be separated in the rule.
- 18 Practice Procedures, 16.6.8. As a general summary,
- 19 the proposed changes to 16.6.8 changes the name naprapathic
- 20 physicians to naprapathic practitioner and also deletes a
- 21 diagnostic procedure that is not used, breaches emergency
- 22 assistance ministry.
- 23 16.6.9 Supervision of Interns. As a general
- 24 summary, the proposed changes to 16.6.9 clarify the
- 25 procedures for the supervision of interns and also changes

- 1 the term doctor to naprapathic practitioner.
- 2 May I remind everyone to sign the attendance sheet
- 3 and be entered into the record at this hearing. Attendees
- 4 via Zoom, your names and titles will be added to the
- 5 transcript.
- 6 Will the Executive Director, Ms. Sondra Frank, call
- 7 the roll of the Board members present for the hearing.

- 3 CHAIR BEAUDETTE: Let the record show that
- 4 Ms. Sondra Frank, the Board's Executive Director, is present
- 5 to advise the Board.
- 6 For the record, would the members of the audience
- 7 please introduce themselves, state their affiliation, and
- 8 inform the Board if they wish to present testimony.

- 11 CHAIR BEAUDETTE: Dr. Saini.
- 12 DR. SAINI: Yes, this is Dr. Saini. I'm a Board
- 13 Licensed physician in New Mexico. My specialty is internal
- 14 medicine and I submitted my comments pertaining to 16.10.10
- 15 NMAC, yesterday through email. I hope the Board will be able
- 16 to review those.
- 17 CHAIR BEAUDETTE: Yes, thank you. The public
- 18 hearing is now open. Ms. Frank, at this time would you have

- 25 CHAIR BEAUDETTE: Are there any questions from the

- 1 Board members?
- 2 (pause)
- 3 CHAIR BEAUDETTE: Hearing none, Exhibits 1 through
- 4 18 are hereby admitted into the record.
- 5 Any persons wishing to testify and who wish to
- 6 submit evidence with their comments shall do so when they are
- 7 recognized to testify. Each document submitted shall be
- 8 introduced as an exhibit into the record. Board members will
- 9 be permitted to ask questions before I rule on the
- 10 admissibility of the evidence. Upon admissibility, each
- 11 exhibit will be marked and numbered and entered into the
- 12 record.
- 13 Would anyone wish to comment on the proposed changes
- 14 to the Board's rules that have been posted and advertised for
- 15 30 days prior to this hearing and that I just summarized on
- 16 the record?
- 17 MR. NUZZO: Hello. I am Patrick Nuzzo and I am with
- 18 Southwest University of Naprapathic Medicine and I just
- 19 wanted to state my full support of the changes as described.
- 20 CHAIR BEAUDETTE: Thank you, sir. Now, would anyone
- 21 else care to comment on the rules that have been posted and
- 22 advertised for 30 days, just as I summarized on the record?
- 23 Dr. Saini, would you -- I'm sorry, go ahead.
- 24 DR. SAINI: Sorry. This is Dr. Saini, the comments
- on 16.10.10. So am I supposed to give my comments now?

- 1 CHAIR BEAUDETTE: Yes, please do.
- 2 DR. SAINI: So I don't know if the Board has my
- 3 written response, or written comments pulled up. Let me just
- 4 pull them up for myself. I think the Board proposes to add
- 5 the locum tenens and staffing agencies to the definition of
- 6 health care entity. And, to my knowledge, I think New Mexico
- 7 will be the only state or jurisdiction which would have such
- 8 a requirement in its policies and procedures.
- 9 The current definition of health care entity is
- 10 pretty similar to the definition which is in the National
- 11 Practitioner Database Guide Book and the Health Care Quality
- 12 Improvement Act, which basically deals with what needs to be
- 13 reported to federal government agencies about certain actions
- on a physician's license or practice. None of those entities
- 15 have locum tenens or staffing agencies as a health care
- 16 entity, primarily for the chief reason that none of these
- 17 agencies actually follow any defined peer review process
- 18 which would give a physician notice of the complaints against
- 19 them, an opportunity to be heard or present evidence in
- 20 support of their viewpoint. And without the proper peer
- 21 review process as the American Medical Association has
- 22 recognized, it is very unfair for physicians to be labeled as
- 23 unqualified or lacking professional competence or conduct.
- 24 So in summary, I will say that if the New Mexico
- 25 Medical Board has locum tenens or staffing agencies which are

1 primarily in the business of staffing hospitals with doctors

- 2 and do not offer any peer review process in case there's any
- 3 event which might reflect poorly on physician's competence or
- 4 conduct, I think the Board is opening up a lot of matters for
- 5 investigation and it will put unnecessary strain on
- 6 physicians and will take time and energy away from patient
- 7 care.
- 8 Thank you.
- 9 CHAIR BEAUDETTE: Thank you, Dr. Saini, we
- 10 appreciate your input. Can I ask, are you practicing in New
- 11 Mexico currently now, or not?
- DR. SAINI: Yes, sir.
- 13 CHAIR BEAUDETTE: What sort of practice do you have
- 14 now?
- 15 DR. SAINI: I work at a rural health clinic as an
- 16 internist.
- 17 CHAIR BEAUDETTE: I see, okay. Thank you. Now, do
- 18 any Board members have any questions of the witness?
- 19 (pause)
- 20 CHAIR BEAUDETTE: Would anybody in the audience care
- 21 to question the witness?
- (pause)
- 23 CHAIR BEAUDETTE: Hearing none. Are there any other
- 24 comments on any of the rule procedures?
- 25 (pause)

1 CHAIR BEAUDETTE: Hearing no other comments, at this

- 2 time the attendance sheet shall be marked as an exhibit and
- 3 entered into the record.
- 4 EXECUTIVE DIRECTOR FRANK: I ask permission of the
- 5 attendance sheet as Exhibit Number 19.
- 6 CHAIR BEAUDETTE: Do we need to vote on that,
- 7 Sondra?
- 8 EXECUTIVE DIRECTOR FRANK: No. You control that, so
- 9 as long as you say, "Exhibit 19 is admitted into the record,"
- 10 then it is admitted.
- 11 CHAIR BEAUDETTE: Exhibit 19 is admitted.
- 12 So the comments submitted and discussion heard
- during the Rule Hearing will be considered and will be
- 14 discussed further by the Board during the Opening Meeting
