**Information on the recent release from HHS regarding pharmacist provision of COVID-19 therapies.**

Ms. Frank provided the Board with the Expanding access to COVID-19 therapeutics and the HHS Prep Act Declaration that was forwarded from the Pharmacy Association, to provide the Board

with updated information on the COVID-19 therapeutics that have been recently amended to provide liability protection to licensed pharmacists, pharmacy technicians and pharmacy interns.

**7. Reports**

**A. Licensing Manager- Audit CME Process**

Ms. Griego provided the Board with information on the CME audit during renewals and the issues the board recognizes for licensees who are not forthcoming on their renewal application. Ms. Griego provided the Board with a proposed policy for handling non-compliant licensees.

**B. Executive Director- Approval of: Ascension St. John, Emergency Room program, which is an ACGME approved program.**

Ms. Frank informed the Board of the rules and regulations for resident physicians enrolling in a rotation in New Mexico and the requirements they must meet to obtain a resident license. One requirement being individuals enrolled in a board approved training programs outside of New Mexico must graduate from or have completed a program approved by the board.

Ms. Frank stated that programs that are not approved by the board but are currently ACGME accredited raises issues for residents enrolling in a rotation in New Mexico. Ms. Frank requested that the Board approve Ascension St. John, Emergency room program that is currently ACGME accredited.

After much discussion, the following motion was made.
