#### 1. CALL TO ORDER

The regular meeting of the New Mexico Medical Board convened at 8:40 a.m., Thursday, February 16, 2006 in the Board Conference Room, 2055 S. Pacheco, Santa Fe, New Mexico, *Paul Kovnat, M.D.* presiding. A quorum was declared, with all members present

# 2. APPROVAL OF AGENDA

Dr. Kovnat MOVED to approve the agenda as presented. YES: Kovnat, Giudice, Weiner, Vigil, Heim, Cochran, Haynes and Ghadimi. ABSENT: Ranka. MOTION CARRIED

Ms. Cochran MOVED to Amend the Agenda to add an interview with a perspective employee for an exempt staff position on Friday at 9:00 a m. Dr. Haynes SECONDED. YES: Kovnat, Giudice, Weiner, Vigil, Heim, Cochran, Ghadimi and Haynes ABSENT: Ranka MOTION CARRIED

#### 3. APPROVAL OF MINUTES

## 8. DECISION AND ORDER

In Case #2005-018, (Robert Graor, M.D.), Dr Graor briefly addressed the Board, and then Administrative Prosecutor GTS Khalsa addressed the Board. MOTION was made by Dr Kovnat and seconded by Dr Haynes to go into executive session to discuss matters of licensure YES: Kovnat, Haynes, Giudice, Weiner, Vigil, Ghadimi, Heim, and Cochran. ABSENT: Ranka. MOTION CARRIED. The Board returned to open session after a discussion of Licensing Issues. Dr. Kovnat stated for the record that the matters discussed in executive session were limited to only those specified in the motion for closure. Mr Heim MOVED to accept the Hearing Officer's recommended Findings of Facts number 1 thru 16 in their entirety. Dr Haynes SECONDED the motion. YES: Kovnat, Weiner, Weiner, Ghadimi, Haynes, Heim and Giudice. ABSENT: Ranka. RECUSED: Vigil MOTION CARRIED.

Dr. Kovnat MOVED to accept the following Conclusions of Law:

- 1 The Board has jurisdiction over the Respondent and the subject matter
- 2. The Board has complied with all notice and hearing requirements of the Uniform Licensing Act and has afforded Respondent all due process required by law. This decision and order is timely rendered.
- The Board concludes that there is conclusive evidence in the record to prove that Respondent's license was revoked by the State Medical Board of Ohio for making false, fraudulent and deceptive statements in documents

connected with the practice of medicine and such revocation imposed by the State of Ohio is based upon acts similar to acts that would be ground for disciplinary action in New Mexico as alleged in the Notice of Contemplated Action

Pursuant to §61-6-15(B) NMSA 1978, the Board has authority and has sufficient evidence in the record to place Respondent's license on indefinite probation for protection of the public and for the purpose of rehabilitation

Mr. Ghadimi SECONDED the motion YES: Kovnat, Weiner, Cochran, Haynes, Giudice, Heim and Ghadimi ABSENT: Ranka RECUSED: Vigil MOTION CARRIED.

Dr. Kovnat MOVED to issue Robert Graor, MD a Stipulated License requiring a mental health evaluation and participation in NM MTP, full disclosure of disciplinary history to all employers and associates, Board approval of practice settings, and other monitoring requirements as specified in the Order. Dr. Haynes SECONDED the motion YES: Kovnat, Weiner, Cochran, Haynes, Giudice, Heim and Ghadimi ABSENT: Ranka RECUSED: Vigil MOTION CARRIED.

# 9. **DECISION AND ORDER**

In Case #2005-016, (Michael Flanagan, M.D.), Dr Haynes MOVED to accept the Hearing Officer's recommended Findings of Facts number 1 thru 13 in their entirety. Mr Ghadimi SECONDED the motion. YES: Kovnat, Haynes, Vigil, Giudice, Heim and Ghadimi ABSENT: Ranka RECUSED: Cochran and Weiner MOTION CARRIED.

Dr Haynes MOVED to accept the following Conclusions of Law:

- 1 The Board has jurisdiction over the Respondent and the subject matter.
- The Board has complied with all notice and hearing requirements of the Uniform Licensing Act and has afforded Respondent all due process rights required by law. This Decision and Order is timely rendered.
- 3. The Board concludes that there is sufficient evidence in the record to prove by a preponderance of the evidence that Respondent committed gross negligence in violation of  $\S61-6-15(D)(12)$  NMSA 1978 as alleged in  $\P$  2(A) of the Amended Notice of Contemplated Action
- 4. The Board concludes that there is sufficient evidence in the record to prove by clear and convincing evidence that Respondent violated Rule 16.10.8.8(H) NMAC and § 61-6-15(D) in that Respondent was dishonest and deceptive as alleged in ¶ 2(B) of the Amended Notice of Contemplated Action and made dishonest, false, fraudulent, or deceptive statements in documents connected to the practice of medicine as alleged in ¶ 2(C) of the Amended Notice of Contemplated Action
- 5. The Board concludes that there is sufficient evidence in the record to prove by a preponderance of the evidence that Respondent violated  $\S61-6-15(D)(26)$  NMSA 1978, in that Respondent is guilty of injudicious prescribing, administering, or dispensing certain drugs as alleged in  $\P 2(D)$  of the Amended Notice of Contemplated Action.
- The Board concludes that there is sufficient evidence in the record to prove by a preponderance of the evidence that Respondent violated Rule 16 10 14 NMAC and §61-6-15(D) as alleged in ¶ 2(F) of the Amended Notice of Contemplated Action
- Pursuant to §61-6-15(A) NMSA 1978 and Rule 16.10 5.1 NMAC, the Board has authority and has sufficient evidence in the record to revoke Respondent's license to practice medicine in New Mexico.

  Mr. Heim SECONDED the motion YES: Kovnat, Haynes, Vigil, Giudice, Heim and Ghadimi ABSENT: Ranka.

RECUSED: Cochran and Weiner MOTION CARRIED.

Dr Haynes MOVED that the Board concludes that there is insufficient evidence in the record to prove that Respondent violated Rule 16.10.8(H) NMAC as alleged in ¶ 2(E) and dismisses ¶ 2(E). Mr. Heim SECONDED the motion. YES: Kovnat, Haynes, Vigil, Giudice, Heim and Ghadimi ABSENT: Ranka RECUSED: Cochran and Weiner. MOTION CARRIED.

Dr Kovnat MOVED to issue Michael Flanagan, MD an Order revoking his license to practice medicine in New Mexico, effective ten days from the date the Order is signed. Mr. Heim SECONDED the motion YES: Kovnat, Haynes, Vigil, Giudice, Heim and Ghadimi. ABSENT: Ranka RECUSED: Cochran and Weiner MOTION CARRIED.

Dr. Haynes MOVED to include in the Order that at any time after fifteen (15) years from the date of this decision and order, Dr. Flanagan may seek licensure by filing a new application for licensure with the Board. If Dr. Flanagan applies for re-licensure, he will have the burden of demonstrating to the Board that

he is capable of the competent practice of medicine with reasonable skill and safety to the public, and the Board may attach whatever conditions it deems appropriate to his practice. Dr. Kovnat SECONDED the motion YES: Kovnat, Haynes, Vigil, Giudice, Heim and Ghadimi. ABSENT: Ranka RECUSED: Cochran and Weiner.

# 10. REPORTS

- A. Chair. Dr Kovnat discussed the Federation meeting to be held in April Eight board members will be attending. The Board has the budget to pay complete costs for the two Board members attending for the first time, and partial costs for all others.
  - B. Assistant Attorney General. No report at this time
- C. Medical Director. Dr. La Farge provided the status of the Practice Management committee. They met with Dr. Cassel on November 22<sup>nd</sup> and then met again on February 3<sup>rd</sup>. Direction and ideas are still under discussion regarding CME credits. The UNM-NMMB ethics CME committee is on hold at this time. The DOH proposal on partner therapy for STDS is still being reviewed by the Department of Health. A current Psychologist prescribing authority application committee is on hold. The Board is still waiting for the required appointment by the psychologist board as to what psychiatrist will serve on the application committee. Dr. La Farge also presented the end of year physician-by-county information.
- **D.** Acting Executive Director. Ms. Mohler presented the Budget update and discussion was held confirming the budget is on target for FY 06. The current status of PA renewals was discussed and a letter will be going out to the PAs who have not renewed reminding them of the March 1<sup>st</sup> deadline. The Board asked staff to develop proposed rule language for PA renewals that matches the license expiration language for MDs, and language that will allow currently licensed PAs one year to pass the NCCPA certification exam. Jenny Felmley gave an update of the 2006 Legislative session. She explained that the original LFC budget had cut approximately \$30,000 from the Board's budget, as a result of a failure to adequately explain the costs of the expanded MTP contract. However, thanks to the assistance of Senator Tim Jennings, the amount was successfully added back into the budget. The Board agreed that a letter of thanks to Senator Jennings is in order.
  - E. Compliance. Ms Felmley reported that all licensees currently under monitoring are in compliance.

Dr. Giudice SECONDED the motion. YES: Kovnat, Haynes, Weiner, Giudice, Cochran, Ghadimi, Heim and Vigil. ABSENT: Ranka MOTION CARRIED.
- C. Medical records rule. Dr Vigil MOVED to adopt the proposed new Part 17 of the rules, 16.10.17, Management of Medical Records with the amendment to section 10, to read: "shredded, incinerated or other method that provides permanent destruction of the records." Dr Kovnat SECONDED the motion YES: Kovnat, Haynes, Weiner, Giudice, Cochran, Ghadimi, Heim and Vigil ABSENT: Ranka MOTION CARRIED
- **D.** Report on malpractice survey. Ms. Felmley presented a survey of malpractice information conducted on current licensees. The Board decided any licensee with three or more malpractice suits in the past ten years shall be sent to a complaint committee for review

Graor, Robert, MD, applicant – Issue an, Order mandating a Stipulated License that requires a mental health evaluation, participation in NM MTP, full disclosure of disciplinary history to all employers and associates, Board approval of practice settings, and other monitoring requirements as specified in the Order

Gritzmacher, Richard, MD, 2000-198 – Issue a Notice of Contemplated Action for disciplinary action based on actions taken in Kentucky and Alabama, and for falsification of his NM license renewal

Hall, Gary, MD, 94-260 – Issue a Notice of Contemplated Action for disciplinary action based on action in another state, failure to notify the Board of action in another state, and falsification of his license renewal applications.

**Pendrak, Robert, MD,** MD2005-0209 – Refer the physician to CPEP, or an equivalent program, for a thorough evaluation of his surgical skills.

**Schwartz, George, MD,** 71-84 – Issue a Notice of Contemplated Action for disciplinary action based on unprofessional and dishonorable conduct and falsification of a renewal application.

**Tong, Rolando, MD,** 89-109 - Remove all stipulations and issue an unrestricted license.

Valencia, Andrew, PA – As part of closure of complaint cases 2004-A-092 and 2005-A-055, send a letter requesting that he cease and desist enhancing his credentials by telling patients that he is an applicant for a PA license; refer case to the District Attorney for possible criminal or adjunctive action for alleged practicing medicine without a license.

West, Ken – Refer case to District Attorney for possible criminal or adjunctive action for alleged practicing medicine without a license
