Mr. Bourbon stated for the record that his employment at UNMH which is at an outlying Clinic did not create a bias against his serving as the hearing officer in Dr. Gollas' case. He had no knowledge of Dr. Gollas when he accepted the role of hearing officer. His employment as a UNMH hospital employee is separate from the school of medicine, which was Dr. Gollas' affiliation and he had no interaction with the medical residency program in any way.

#### A. Chair –

#### B. Executive Director

1. Personnel Issues – Ms. Hart advised that the Board is recruiting for one position. The Board has also requested an additional FTE in its budget request for FY14. Ms. Hart and Ms. Mascarenas presented that request to the House legislative finance committee. Both the DFA and the Legislative Finance Committee put the requested position in the Board's budget. Our request is included in House Bill 2, upon passage of HB2, the new position will be eligible for recruitment July1.

**2.** Litigation against the Board – A suit has been filed against the Board by Richard Rubin, PA, in Federal Court for a civil rights violation. Dr. Jenkusky is named in the suit, along with Dr. Weiner; Mr. Rubin and Lynn Hart. Risk management will take over the Board's defense.

3. Dr. Jain will appeal the Board's revocation of his license. Ms. Hart suggested that the Board appoint Mr. Rubin to handle the appeal.

#### C. Prescription Drug Misuse & Overdose Prevention & Pain Management Advisory Council – Dr. Jenkusky

Dr. Jenkusky was appointed by the Board to be its representative. The Advisory Council met several times throughout the year. Ms. Hart or another Board staff person attends as well. The Council's job is to make recommendations to the Governor on the proper use of controlled substances for the treatment of pain. At the last meeting in December 2012, the council voted as a group for two pages of recommendations for possible legislative action or for rule adoption. The most controversial item that the Council considered and voted down by considerable margin was the imposition of prescription pain drug dosing limits and the duration of treatment with opioids.

Representatives, including the medical board, met with staff members of the Governor's office and discussed a legislative option that would give the Council the authority to create prescription limits for opiates and other controlled drugs; including the duration of treatment and doses. Under the proposal, the licensing boards would be mandated to adopt the regulations. Representatives at the meeting voiced concern about this approach. Limits will remain an option, however, as our state battles prescription drug overdose.

Ms. Hart added that the Council's two pages of recommendations were not discussed in detail, but were assumed to be accepted by all. Many Council members were not in attendance.

#### D. Medical Director - Board Sponsorship of USMLE Step 3

The United States Medical Licensing Examination (USMLE) was implemented in the 1990's. It was established to take the place of the National Board of Medical Examiners (NBME) exams. Initially, these exams both required that any MD sitting for step 3 of the USMLE be sponsored by a Medical board to take the exam. Currently, the NMBME and the USMLE are re-shaping the USMLE. They have decided no longer to require sponsorship as of mid-2014. The exam will be much simpler, more integrated, and easier to register for and complete.

# H. Financial / HR Manager

#### Review FY13 Budget - Revenue Status Report

Ms. Mascarenas reported that the FY13 operating budget is \$1,620,000. Expenditures ending December 31<sup>st</sup> were \$739,000 or 45 percent of the total operating budget. In FY13 the Board has to comply with the 50% rule which means that we cannot expend more than half of the budget by the end of December. Revenues collected are \$291,000 or 17.9 percent of the total operating budget. As of today the cash balance is \$1,402,000 but obviously this balance will go down because income accrues again in April through June of this year.

In January the Board had to do a within-program Budget Adjustment Request (BAR) to move funding to cover some of the administrative costs, primarily litigation. The Board spent about \$30,000 on litigation in the period ending December 31<sup>st</sup>. This amount is up from prior years. Last year the Board spent \$16,000 for the entire fiscal year on litigation; \$10,000 the year before and \$9,000 the year before that. We are still projecting to spend another \$30,000 this fiscal year; between now and the end of June.

# • Approval of Audit

The FY1-2012 Audit was successful with no negative findings. This year the Board will need to solicit a new audit firm because last year was Macias, Gutierrez & Company's last year.

This will be a 7.1% increase over the current operating budget, or about \$114,000. The increase is in all categories but primarily for the expansion personnel position.

# I. Investigation Department

- Status Report
- Ms. Dieterich updated the Board on the current status of investigation cases. A discussion was held about the percentage of cases that are alternatively being taken to the Executive Committee for their review and determination on whether formal investigations should be initiated. This is per the Board's policy established in 2008. The Board receives a number of complaints which it does not have jurisdiction over and which do not violate the Medical Practice Act or Rules. Those complaints are typically not formally investigated at the discretion of the Executive Committee (EC). Others such as anonymous complaints and those where the complainant has no "first-hand" knowledge of the alleged infraction are also taken to the Executive Committee. The Executive Committee determines if a case warrants a formal investigation and upon whose behalf as a Board complaint or on behalf of the complainant. Again, per the 2008 policy, the whole board reviews a summary of the cases the EC does not send to investigations; any board member can direct a case to investigations.
- Attorney General's Task Force on Prescription Drug Abuse in NM

Ms. Dieterich informed the Board that she attended a teleconference meeting with the Attorney General's office regarding their formation of a task force to deal with the prescription drug abuse problem in New Mexico. The Attorney General's task force has asked the Medical Board to give a presentation at their awareness summit, which is to be scheduled in April.

**11. Steve Jenison, MD –** The Medical Board's interpretation and application of the Lynn & Erin Compassionate Act

Dr. Jenison introduced himself to the Board as an infectious diseases physician and advised all that he had worked for the Department of Health for 14 years. As the Medical Director of the Infectious Diseases Bureau at DOH, he was also the Medical Director of the Medical Cannabis Program from 2007 until 2010. Since then Dr. Jenison has been the Chair of the Medical Advisory Board to the Medical Cannabis Program, which is a group established by the Lynn & Erin Compassionate Use Act. The duties of the Medical Advisory Board are to hear petitions from people who want to add new conditions to the list of those who meet eligibility requirements for enrollment in the medical cannabis program, and to hear appeals of denials of patient registry.

The medical cannabis program has three main components. One is the establishment of a patient registry. The purpose of the patient registry is to protect patients with certain specified medical conditions from arrest and prosecution for the possession of a reasonable amount of medical cannabis for their personal use. The second component of the program is the medical advisory board, and the third component is the licensed producer. There are currently 23 licensed producers on medical cannabis in New Mexico. These licensed producers can grow a specified amount of cannabis. The patients in the medical cannabis program have to re-certify each year. According to Dr. Jenison, since many of the patients of the program.

Dr. Jenison wanted to address the Board concerning certain recent NCA's issued by the Medical Board. He expressed concern regarding the relevance of the use of the term "prescribe" and the use of the term "primary caregiver in previous Board documents.

Dr. Jenison asked the Medical Board if they would consider establishing a small task force that can review the position of the Medical Board along with the position of the DOH regarding the medical cannabis program.

There was extended discussion on this issue. Dr. Weiner stated that Dr. Kankanala and Dr. Jenkusky would be good candidates to review these issues more thoroughly and report back to the Board. Perhaps the Board can also discuss this issue internally and present a position on rules and certification at the next board meeting.

Mr. Rubin suggested that Dr. Kankanala and Dr. Jenkusky serve on the medical cannabis rules task force. They agreed.

#### 12. NEW BUSINESS:

**A.** Appoint Task Force to draft Board Regulations on Certifications for the Use of Medical Cannabis Pursuant to the Lynn and Erin Compassionate Use Act

Mr. Hart suggested that the Board consider drafting and adopting rules that address Medical Cannabis; medical board licensees are authorized to certify patients with approved diagnosis for treatment with cannabis, therefore they have to adhere to the Medical Practice Act. A task force should be made up of board members and staff and the members should be charged with consulting with others who need to be part of the process.

**B.** Appointment of a Task Force to amend Board Regulations on Complaint Procedures and Institution of Disciplinary Action (16.10.6 NMAC).

A task force needs to be created to review current rules and recommend changes if needed to the Board's rules regarding complaint procedures; this is needed in light of the board's upcoming sunset review by the Legislature. The task force would be made up of board members and staff, and be charged with consulting other experts as needed. Dr. Kovnat, Mr. Bourbon and Mr. Rubin volunteered to be on the complaint procedures task force. Other board members offered to participate as needed.

#### **C. Legislative Proposals**

- SB6 Anesthesiologist Definition Anesthesiologist Assistants This bill is probably dead again because the CRNA's are fighting the proposal to expand the services of AA to other hospitals in New Mexico.
- Psychologist Prescribing There is talk that there will be a prescribing psychologist bill that would expand what psychologists can prescribe beyond psychotropics.
- 3. Nursing Board Practice Act Proposals What is proposed would allow the Nursing Board to authorize RN's to do certain types of anesthetic sedation. The ER physicians are in favor of this rule change but the anesthesiologists have concerns about training, skill and experience.
- HB115 Safe Injections
   This bill requiring practitioners to attest to compliance with the CDC requirements for safe injections is basically dead.
- 5. HB170 Volunteer Health Practitioner Exemption This bill on proposed volunteer Physicians has been re-drafted
- 6. HB222 Scope of Practice-Health Professions

This bill would create a panel that reviews and recommends changes in scope of practice. The Medical Board supports this bill.

- HB260 DOM Imaging Licensure exemption This bill seeks to allow DOMs to do sonographic imaging under exemption from the Medical Imaging and Radiation Therapy Health and Safety Act.
- 8. HB 414 Nurse Practitioner Scope of Practice This is a scope of practice for advance practice nurses and nurse mid wives. This bill would enable PA's, nurse practitioners and certified nurse mid wives to certify someone as disabled. This Board is recommending that "licensed in New Mexico" be included in the language for each profession.
- HJM 25 Safe Injection Practices CE Requirements This bill will be re-written to create a study on safe injections, as there is a hepatitis C outbreak in New Mexico, mostly due to self-injection.
- 10. Legislation to control pseudo-ephedrine This bill seeks to require that pseudo-ephedrine products be added to the PMP.
- 11. SB342 Imaging Licensure exemption for Nurses This bill seeks to allow Nurses to do sonographic imaging under exemption from the Medical Imaging and Radiation Therapy Health and Safety Act. NMMB supports

Ms. Hart also discussed a bill for the chiropractors that would eventually take the NMMB out of having to approve their formulary, or their schools.

- D. FSMB Annual Meeting April 18-20, 2013 Boston, MA Ms. Hart asked if any board members would like to attend this meeting, stating that FSMB will pay for one board member and one staff member to attend.
