#### 8. New Business

**2017 Proposed Meeting Dates** – The Board determined that meeting dates will be on February 9-10, 2017, May 11-12, 2017, August 10-11, 2017 and November 2-3, 2017.

The 2017 Interim Meeting dates will be on March 30, 2017, June 29, 2017, September 28, 2017 and December 14, 2017.

CDC Opioid Prescribing Guidelines - Dr. Jenkusky reported on the CDC's Opioid Prescribing Guidelines, he stated that it is a long article about the research that went into the recommendation. He directed the Board to the summary table and reviewed the table of guidelines in its entirety. He explained that these guidelines drove the law that was passed during the last legislative session and now the Board is proposing rules to reflect the law.

Proposed Rule Change to 16.10.13 NMAC — Dr. La Farge reviewed the proposed changes to Part 13 regarding Medical Assistants. The Board discussed at length Medical Assistants in general and their level of training and certification. They deferred their decision and discussion to Friday for further research. On Friday Dr. Komadina shared an outline of Medical Assistant Concepts for the Staff to try and incorporate in the rule as part of the proposed change. A small committee will be formed consisting of staff and Dr. Komadina to draft a proposal for the Board.

**Proposed Rule Change to 16.10.14 NMAC** – Dr. Jenkusky and Ms. Frank reviewed the process for Rule Changing. Sondra explained that the Board is mandated by SB263 to change the PMP portion of 16.10.14 prior to January 1, 2017. After extensive review and discussion the Board decided to add

Schedule V to the PMP portion of the rule and to add an exemption to the requirement of pulling PMP for stimulant therapy for pediatric patients less than age 14. There were several other minor clerical corrections.

Request to amend application for licensure to add questions regarding investigation of licensees by healthcare entities - Ms. Dieterich presented a proposal to amend professional practice question #10 on the licensure applications FROM:

10a. "Have your privileges at any healthcare entity ever been voluntarily or involuntarily suspended, restricted, diminished, revoked, surrendered, or not renewed, except for medical records delinquency?" 10b. "Have you ever agreed not to exercise your clinical privileges while under investigation?" TO:

10a. "Have your privileges at any healthcare entity ever been voluntarily or involuntarily suspended, restricted, diminished, revoked, surrendered, or not renewed, for any reason, except for medical records delinquency <u>unrelated to your professional competence or conduct?</u>"

10b. "Have you ever agreed not to exercise your clinical privileges while under investigation?"

10c. "Have you ever been investigated and/or terminated by a healthcare entity for cause, or without cause, related to your clinical competence or conduct, which could impact patient safety/care, or allowed to resign in lieu of termination for such reason?"

Opioid Use Disorder Treatment Expansion Act / CARA – Mr. Bourbon reported that the President signed and passed the Act and that the expansion included PA's and NP's are able to prescribe Buprenephorine now, he further stated that this is a step in the right direction. Ms. Frank briefly reviewed the CARA act for the Board.

#### 10. REPORTS

#### Chair Report

Medical Marijuana Recommendations from FSMB – Dr. Jenkusky reviewed the FSMB's recommendations regarding medical marijuana prescribing and physicians using medical marijuana. Dr. Jenkusky stated that as a member of the Board he is questioned a lot about the authorization of medical marijuana. He is asking if the Board can use these recommendation as a standard when assessing the proper use of medical marijuana in New Mexico. He also stated that MTP has requested guidance from the Board regarding physicians using medical marijuana. The Board discussed the different issues at length. Ms. Frank explained that the guidelines would have to be made into regulation for them to be used as disciplinary action by the Board on licensees. The Board decided to send it back to staff to try and figure out if and how to incorporate the guidelines into a regulation and in the meantime post to the website to alert the public and licensees that this is what the Board is contemplating.

Guidance on Physician Medical Marijuana Use While in MTP – This was discussed along with the above recommendations from FSMB. The Board decided to send it back to staff to try and figure out if and how to incorporate the guidelines into a regulation and in the meantime post to the website to alert the public and licensees that this is what the Board is contemplating.

#### Licensing Manager

Ms. Orender provided the Board with a copy of the Arizona Medical Board's Medical Practice Act Training and Questionnaire from their paper renewal. It is a "training module" used to increase awareness of the rules and statutes in AZ. On the online renewal application the licensee checks a box stating they've read through it. Dr. Carson suggested offering proof of one hour CME at the end of the

renewal. The Board instructed Ms. Orender to write up questions to present to the Board at the November meeting.

#### Financial / HR Manager

Ms. Mascarenas reported on the FY16 Budget/Revenue Status ending June 30, 2016. She stated that Expenditures total \$1,676.9 (or 90.9%) from July 1, 2015 thru June 30, 2016 (Opbud \$1,844,500). Revenues collected from July 1, 2015 through June 30, 2016 total \$2,041.0 (or 15% over the budgeted amount of revenues which is \$266,459 over \$1,774.5 budgeted revenues. The agency also budgeted \$70.0 FB. The Cash Balance as of August 18, 2016 is **\$1,453.2**.

The FY18 Appropriation Request is due to DFA and LFC by September 1, 2016. Please refer to the S-8 Financial Summary under FY2018 Agency Request.

#### \$1,820.0 Other Revenues and \$80.0 FB

The appropriation request includes converting the vacant part-time attorney position into a full-time position and a built-in vacancy rate of 5.8% in the 200 category. Additionally, the request includes adjusted funding in contractual services for Hearing Officer Services and a slight increase for the upcoming RFP in FY17 (MTP Services). The Operating Costs include a slight increase for the building lease, otherwise is close to the FY7 Operating Budget in this category. The Board needs to vote to approve the FY18 Appropriation Request.

#### 11. Old Business

**PMP Report** – Ms. Quintana reported that the Board has not received an updated PMP Report Card from the Pharmacy Board. Dr. Jenkusky requested that a letter be written from the Board to the Pharmacy Board and DOH regarding this issue.

#### Review of "First Referral Program"

Ms. Frank and Ms. Quintana reported that during the first year of the pilot project the Board named the First Referral Program, only one licensee qualified. The Board decided to stop the program and reevaluate different options for licensees.

#### 12. New Business

# **CNCP Program Presentation**

Danelle Callan, MA from the Department of Family and Community Medicine (DFCM) presented The Health Extension Regional Officer (HERO): Translating Research Into Localities (TRalLs) course called "Best Practices for Treating Chronic Non-Cancer Pain in Primary Care: A Pragmatic Clinical Algorithm Approach." HERO TRalLs project was an AHRQ funded grant that was implemented to study how to best disseminate established guidelines and evidence-based information to primary care providers of rural, underserved, multiethnic populations. This project enabled the team at the DFCM to create an adaptive clinically relevant CNCP tool kit that can be disseminated though workshops and one-on-one academic detailing sessions across New Mexico in partnership with the DOH.

The educational model for CNCP is to deliver evidence based information in a more relevant way; use a practical approach to treating CNCP, similar to other chronic diseases; provide clinically oriented algorithms with tools suggested in the literature and indicate where the NMMB regulations and CDC guidelines "fit" in the clinical process.

The Board approved this course as meeting the requirements to fulfill the Board's 5 hours of Pain Management CME.
