The Budget and Revenue Status ending June 30, 2017 are as follows:

Expenditures total \$1,716.1 (or 90.75%) of budgeted expenditures from July 1, 2016 thru June 30, 2017 (Opbud \$1,891,000);

Revenues collected from July 1, 2016 through June 30, 2017 total \$2,155.1 (or 120%) of budgeted revenues in the amount of \$1,791.0. The agency also budgeted \$100.0 FB in FY17.

Ms. Mascarenas gave the Board the FY17 Statistics Summary that reflects the application/renewal and other fees data that makes up the total revenue received in FY17 of \$2,155.1.

The Fund Balance on June 30, 2017 is \$771,404.54.

The Cash Balance in FY18 as of August 9, 2017 is \$202,180 (revenues received from 7/1/17 - 8/9/17). (As of August 9, 2017 the agency has expended \$134,925.46 and encumbered \$553,761.05) – Cash balance after expenses is \$67,254.54.

FY19 Appropriation Request

Ms. Mascarenas reported that she attended the annual mandatory training held by the State Budget Division regarding the FY19 Appropriation Request. Next week she will begin working on the FY19 Appropriation Request for the period that starts on July 1, 2018 through June 30, 2019. By Statute the Appropriation Request is due by September 1 of every year. At the next board meeting the Board will need to vote to approve the FY19 Appropriation Request. The request will be similar to the current FY18 Operating Budget.

12. Jonathan Bolton, MD – UNM Office of Professionalism Presentation

The UNM HSC Office of Professionalism was established in July 2011 by Paul Roth, MD, MS, Chancellor for Health Sciences, to promote humane medical care, effective teaching and a respectful work environment. The program activities encourage professionalism in clinical work, administration and teaching. The goal is to contribute to the standardization across departments and institutions in the assessment of professional behavior. The program will take referrals from agencies for reports of

unprofessional behavior, and when appropriate, provides recommendations to the involved parties and agencies guidelines and courses for remediation.

13. New Business

PA Amendment of Rules

Ms. Frank reported to the Board the PA Rules Committee would be meeting right after the Board meeting adjourns to discuss the PA Rules. We can have a Rule Hearing in November if we have a final draft ready for Board approval at the September 28, 2017 Interim meeting. We really want written comment from the public prior to the Hearing for Board review and to keep the hearing on schedule. Mr. Bourbon stated that the biggest issue that will probably be discussed in committee is have two differently licenses, a supervised license and a collaborating license, or maintaining one license for both qualifications. Mr. Bourbon endorses having one license and not splitting the two. Mr. Bourbon introduced Sabrina Johnson, President of the NM PA Academy, to thank the Board. She explained she has been working hard to get the Collaborative License Bill passed to help reflect PA's current practice in New Mexico. She discussed the steps that were taken to get to this point and necessity of this bill to help with primary care in rural areas.
