## 7. REPORTS

**A. Chair** – Consider Appointment of a Task Force to Review the Medical Board’s Involvement with the Chiropractic Task Force – Discussion on this item was postponed.

**B. Executive Director** –

FSMB attendees - Ms. Hart reported that Ms. Cochran, who has been nominated to run for the Board of Directors of the Federation of State Medical Boards, will be our voting delegate at their Annual meeting in Seattle. Dr. LaFarge will also attend as our staff representative.

Ms. Hart provided an overview of the follow bills that have been introduced in the 2011 Legislative Session:

- **SB101** Responses to Medical Board Subpoenas – SB 101 would amend the Review Organization Immunity Act to require health care review organizations to respond to Board subpoenas to obtain peer review records. SB 101 has passed through the Senate and is now in the House.
- **SB14** Healthcare Work Force Data Collection – SB 14 directs the Department of Health to collect and analyze data on the state’s health care work force. SB 14 also directs all health care licensing boards to collect additional data from applicants for licensure. SB 14 has passed through the Senate and is moving through the House.
- **HB99** Anesthesiologist and Assistant Licensure – HB 99 would amend the definitions of “anesthesiologist” and “anesthesiologist assistant” as used in the Anesthesiologist Assistants Act, by dropping the requirement from both definitions that the defined person be an employee of the University of New Mexico Medical School. HB 99 has passed one House Committee.
- **HB107** Naprapathic Board Duties to Medical Board – HB 107 proposes to transfer the function and duties of the Naprapathic Practice Board to the Medical Board and creates a task force that would advise the Medical Board regarding licensure of Naprapaths. HB 107 has passed the House and is in the Senate Public Affairs Committee.

- **HB127** Chiropractor Prescriptions & Procedures – HB 127 provides for a Certified Advanced Practice Chiropractic Physician to prescribe and administer drugs that are used in primary care practice. HB 127 was amended in the House and the Medical Board remains responsible to approve the formulary along with the Board of Pharmacy. HB 127 passed the House and is now in the Senate.
- **SB323** Health Care Provider Requirements (Name Tags and Advertising) – SB 323 would amend sections of the Trades Practices Regulations, Advertisement of Health Care Services laws. SB 323 has passed one Senate Committee and is in Senate Judiciary Committee.
- **SB332** Amend Medical Practice Act and Duplicate Bill HB282 – SB 332 and HB 282 are duplicate bills that would amend the Medical Practice Act to provide for the licensing of certain business entities. Neither of these bills has passed through the first assigned Committee.
- **SB333** Amend Medical Malpractice Act and Duplicate Bill HB267 – SB 333 and HB 267 are duplicate bills that would amend the Medical Malpractice Act to define “business entity” and “health care provider” in order to clarify that business entities are included as health care providers under the Act. HB 267 has not passed through the first assigned Committee. SB 333 was amended in its first Committee to increase the “caps” and is now in Senate Judiciary Committee.

**C. Medical Director** – No report at this time.

**D. Licensing Manager** – No report at this time.

**E. Administrative Prosecutor** - Mr. Marshak went over his case status report.

**F. Assistant Attorney General** – No report at this time.

**G. Financial / HR Manager** – Approve 2010 Annual Audit; Budget Status Report – FY 2011. Ms. Mascarenas reviewed the FY2011 Budget Status Report and reported that this was the year, by statutory requirement, to meet 50% of our budget by December, 2010. **MOTION** was made by Dr. Crespin to accept the 2010 Annual Audit. **SECONDED** by Ms. Cochran. **YES:** Dr. Weiner, Ms. Abeles, Ms. Cochran, Dr. Kovnat, Dr. Wehr, Dr. Crespin, Dr. Miller, Mr. Bourbon and Dr. Jenkusky. **MOTION CARRIED.**
