- 7. Rule Review Naprapathic Rules, Parts 1 through 11 MOTION was made by Dr. Weiner to approve the proposed revisions to the Naprapathic Rules, Parts 1 through 11 for a rule Hearing to be held on Friday, August 12, 2011. Case No. 2008-A-149 and 2008-A-210 () RECOMMENDATION was made by Dr. Kovnat to offer physician an Agreed Order of revocation. If physician does not accept, issue a Notice of Contemplated Action based on, but not limited to, a felony conviction. YES: Ms. Abeles, Ms. Cochran, Dr. Kankanala, Dr. Miller, Mr. Bourbon, Dr. Jenkusky and Dr. Weiner. ABSTAINED: Dr. Kovnat. RECOMMENDATION PASSED.

Case No. 2011-B-020 RECOMMENDATION was made by Ms. Cochran to refer this case back to Investigations.

Case No. 2010-B-105 (Kathleen Van Osten, M.D.) RECOMMENDATION was made by Ms. Cochran to offer physician a stipulated license requiring mandatory participation in the NM Monitored Treatment Program and other standard substance abuse stipulations along with the condition that physician practice initially in a low acuity setting.  - A. Robert Perez-Gautin, M.D. Consider non ACGME post graduate training in lieu of 2nd year of accredited training and grant unrestricted medical license. MOTION was made by Dr. Weiner to ACCEPT the non-ACGME post graduate training in lieu of 2nd year of accredited training and GRANT Dr. Perez-Gautin an unrestricted license to practice medicine in New Mexico.  MOTION was made by Dr. Weiner to ACCEPT the UNM Mini-sabbatical report and GRANT an unrestricted license to practice medicine in New Mexico. SECONDED by Ms. Cochran. YES: Dr. Weiner, Dr. Miller, Ms. Abeles, Dr. Kovnat, Mr. Bourbon, Ms. Cochran, Dr. Kankanala and Dr. Jenkusky. MOTION CARRIED.
 - C. Decision and Order Claude Gelinas, M.D.
 MOTION was made by Ms. Cochran to ADOPT the Hearing Officer's Report in its entirety and in the Conclusion of Law the Board did not find sufficient evidence to conclude that there was a violation of the Medical Practice Act as alleged in the Notice of Contemplated Action. An ORDER of dismissal will be issued with an Advisory Letter warning him that he should exercise abundant caution and circumspection at all times if imbibing alcohol in order to guard against events of this nature occurring in the future and to assure to the public that he is and always remains a valuable asset to the patient community he serves. Dr. Gelinas is further cautioned to explore, introspectively or with professional assistance, including the Monitored Treatment Program, issues surrounding imbibing alcohol.  - Decision and Order Chinonyerem Osuagwu, M.D.
 MOTION was made by Dr. Weiner to ADOPT the Hearing Officer's Report in its entirety and in the Conclusion of Law the Board did not find sufficient evidence to conclude that there was a violation of the Medical Practice Act as alleged in the Notice of Contemplated Action. An ORDER of dismissal will be issued with an Advisory Letter informing him that he must report to the Medical Board any adverse action taken by any health care entity regarding his privileges. SECONDED by Dr. Kovnat. YES: Dr. Kovnat, Mr. Bourbon, Dr. Kankanala, Dr. Jenkusky, Dr. Miller, Ms. Cochran and Dr. Weiner. RECUSED: Ms. Abeles. MOTION CARRIED.

E. Decision and Order – Barry Maron, M.D.

MOTION was made by Dr. Weiner to ADOPT the Hearing Officer's Report in its entirety and in the Conclusion of Law the Board concludes that Respondent poses a clear and immediate danger to the public health and safety if he continues to practice medicine, and, therefore, that the Board's summary suspension order should remain in effect until further order of the Board. It is ORDERED that the Medical Board's summary suspension order of Dr. Maron is continued and remains in effect until further order of the Board. SECONDED by Ms. Abeles. YES: Dr. Kovnat, Ms. Abeles, Dr. Kankanala, Dr. Miller, Ms. Cochran and Dr. Weiner. RECUSED: Dr. Jenkusky and Mr. Bourbon. MOTION CARRIED.

F. Steven Black, M.D. - Consider Settlement

MOTION was made by Dr. Weiner to APPROVE the Stipulated Agreement as presented, but also amend it to require affidavits be submitted quarterly, and that physician be required to appear quarterly before the Board. Also, Dr. Black's file will be reviewed on an annual basis. SECONDED by Dr. Kovnat. YES: Dr. Weiner, Ms. Abeles, Dr. Kankanala, Dr. Miller, Ms. Cochran and Dr. Kovnat. RECUSED: Dr. Jenkusky and Mr. Bourbon. MOTION CARRIED.
