5. Executive Director

A. Update on the posting of the proposed pain management rule and letter to licensees.

They are instructing the individuals to put their comments in writing and that the whole board will hear the debate of the rule.

Committee A:

Case No. 2012-A-067 (Aida Figueroa, M.D.)

RECOMMENDATION was made by Dr. Kovnat that physician be ordered to undergo an evaluation under the Impaired Health Care Provider Act. If physician fails to appear before the examining committee as ordered, pursuant to 61-7-5(E) of the Act, the committee recommends that the Board summarily suspend physician's license to practice. Committee recommends that the Board Chair be designated to sign the summary suspension order. Simultaneously with proceeding under the Impaired Health Care Provider Act, the complaint committee recommends issuance of a Notice of Contemplated Action based on, but not limited to, licensure action being taken against the physician by another state. YES: Dr. Weiner, Dr. Jenkusky, Dr. Miller, Ms. Cochran, Dr. Kankanala, Mr. Bourbon and Dr. Komadina. ABSTAINED: Dr. Kovnat.

RECOMMENDATION PASSED.

Committee D:

Case No. 2012-D-027 (Mike Bellas, PA)

RECOMMENDATION was made by Dr. Jenkusky to offer the physician assistant a stipulated license requiring mandatory participation in NM Monitored Treatment Program and other standard substance abuse stipulations, along with

a restriction on prescribing controlled substances schedules II-V for a period of at least one year, after which time physician assistant may petition the board to reinstate. If he does not accept, recommend issuance of a Notice of Contemplated Action based on, but not limited to, habitual use of substances and injudicious prescribing. **YES:** Dr. Kovnat, Dr. Weiner, Dr. Miller, Ms. Cochran, Dr. Kankanala, and Dr. Komadina. **ABSTAINED:** Dr. Jenkusky and Mr. Bourbon. **RECOMMENDATION PASSED.**

Case No. 2012-D-005 (Deborah Aaron, M.D.)

RECOMMENDATION was made by Dr. Jenkusky to accept the Impaired Physician Committee's recommendations and offer physician a stipulated license requiring mandatory participation in NM Monitored Treatment Program and other standard substance abuse stipulations. If physician does not accept the stipulated license, a Notice of Contemplated Action will be issued based on, but not limited to, habitual use of alcohol, and violation of a drug law. **YES:** Dr. Kovnat, Dr. Weiner, Dr. Miller, Ms. Cochran, Dr. Kankanala, and Dr. Komadina. **ABSTAINED:** Dr. Jenkusky and Mr. Bourbon. **RECOMMENDATION PASSED.**

Case No. 2011-D-163 (Pawankumar Jain, M.D.)

RECOMMENDATION was made by Dr. Jenkusky to issue a Summary Suspension based on physician's immediate danger to the public, simultaneously with a Notice of Contemplated Action based on, but not limited to, injudicious prescribing, failure to maintain adequate medical records, and gross negligence. **YES:** Dr. Kovnat, Dr. Weiner, Dr. Miller, Ms. Cochran, Dr. Kankanala, and Dr. Komadina. **ABSTAINED:** Dr. Jenkusky and Mr. Bourbon. **RECOMMENDATION PASSED.**
