6. REPORTS

- A. Chair Dr. Weiner asked that Ms Cochran, Ms. Hart, and Dr. La Farge report on some of the important issues that were discussed at the 2012, 100th Anniversary meeting of the Federation of State Medical Boards. Their report follows:
 - Current status of <u>medical manpower</u>. There are 850,055 licensed physicians (MD/DO) in the U.S.A., 25% of whom hold more than one State license. Physicians with Telemedicine licenses frequently have 30 to 40 State licenses. Key issues in manpower relate to how many physicians are in full or part time practice, or simply maintain an active license without practice. Better future distribution will also be mandatory, as will more graduates from medical schools.
 - Strong emphasis was given to the requirement that <u>physicians must be</u> <u>licensed first before they accept a position</u>, or move to another State and buy a house! The concept is that a "complete residency" is basically three years, though surgical specialties may take longer in order to complete training.
 - Several speakers and sessions emphasized the necessity for <u>adequate</u> <u>training in opiate pharmacology, prescription, safeguarding of medication</u> (secure

medicine cabinets), and proper disposal. Further, ongoing CME must be required for practitioners treating chronic pain, as well as the frequent and appropriate use of the prescription monitoring programs ("PMP") that are now active in all but two States. Dr. Fishman discussed the new edition of his book on "Responsible Opioid Prescribing" with emphasis on the enormous increase in substance use disorders and overdose deaths in many States and the role of physicians as risk managers.

- The concept of and need for <u>expedited licensure</u> was thoroughly discussed, with emphasis on criteria for identifying specific attributes of a category of physicians that could allow other States to "fast-track" an application rapidly, without duplicating prior, in-depth document re-checking. A national repository of such information, online, will be necessary, and the FSMB's FCVS (Federation Credentials Verification Service) is being revised to attain that capability.
- The issue of Senator Udall's "<u>national license</u>" proposal—and Bill—was also discussed during several sessions, with emphasis on issues of protection of the public being a State responsibility, and re-emphasis on the importance of licensing fees being necessary to the support for the investigation and discipline of problem physicians. There was little support expressed for national licensure.
- The concept of practicing medicine on "social networking sites", like "Facebook", was also reviewed in depth, noting a significant increase in complaints about breach of privacy and the "fuzzy" nature of the boundary between confidentiality and the very public nature of communication on social media. Further emphasis was placed on professionalism, ethical and truthful communication, and the three basics: candor, privacy, and integrity in maintaining an appropriate physician-patient relationship, as stated in the FSMB's "Model Policy on Social Media and Networking in Medical Practice".
- B. Secretary / Treasurer National Licensure Bill Update Dr. Kovnat and Ms. Hart provided an update on the current status of the National Licensure Bill that is about to be introduced by Senator Tom Udall. Both the Federation of State Medical Boards and our NM board oppose this bill. The Federation is addressing some of the specific issues in the Bill that we, along with other state boards, also oppose. Ms. Hart stated that we, as well as the Federation, had attempted to explain the problems inherent in the Bill to Ms. Fern Goodhart, Senator Udall's legal assistant, but to no avail. Ms. Hart added that the proposed Bill does not make allowance for individual States' rights and responsibilities for protecting their citizens in matters of medical malfeasance. The Federation along with its hired a lobbyist will be following the proposed bill through the congressional committee hearings.
- C. Executive Director Lynn Hart, Executive Director, reported that our new Administrative Prosecutor, Dan Rubin will officially start on May 21st. She acknowledged and thanked Jerry Marshak for having served the board during the interim between prosecutors.

D. Rule Review

• 16.10.14 NMAC – Management of Chronic Pain with Controlled Substances

Ms. Hart gave an overview of what is required by Senate Bill 215, amending the Pain
Relief Act, to amend our rules or create a rule that would mandate that licensees who
prescribe controlled substances be required to obtain a certain number of educational
hours in every renewal cycle. Also required is that all practitioner licensing boards adopt
guidelines or regulations for clinical procedures for treating pain. The Board needs to
publish the rule for public comment in order to have a rule hearing in August.

Dr. Jenkusky has been leading a workgroup discussing the requirement for continuing
medical educational hours as well as rules for the procedure for treating chronic pain. The

medical educational hours as well as rules for the procedure for treating chronic pain. The workgroup identified an urgent need to establish educational requirements within the next year instead of waiting for the regular licensee renewal cycle.

Dr. Jenkusky, along with Dr. Katzman and Dr. Commerci, (of the ECHO Program), spoke to the Board regarding other state mandates and the need to adopt chronic pain requirements to protect the public.

Discussion was then held among the Board Members regarding the requirements of continuing medical education hours. It was the consensus of the Board to require ten hours every three-year renewal cycle, including five defined hours during the first year after the rule goes into effect, or within the first year after licensure.

Dr. Jenkusky discussed the Prescription Monitoring Program "PMP" that will require all doctors to register and to use it appropriately during treatment of chronic pain.

MOTION was made by Dr. Weiner to approve the amendments of 16.10.14 NMAC as presented, send it out for public comment and schedule a Rule Hearing at our 3rd Quarterly meeting in August. **SECONDED** by Ms. Cochran. **YES:** Mr. Bourbon, Dr. Jenkusky, Dr. Kankanala, Dr. Miller, Dr. Komadina, Dr. Weiner and Ms. Cochran.

ABSENT: Dr. Kovnat MOTION PASSED.

- **E. Proposed Pharmacy Regulations -** Dr. LaFarge briefly discussed the proposed amendments to the following Pharmacy Board rules.
 - 16.19.4 NMAC Pharmacy
 - 16.19.20 NMAC Controlled Substances
 - 16.19.29 NMAC Controlled Substance Prescription Monitoring Program
- F. Support Exempting Nurses from Medical Image Licensing - Linda Siegle, a representative of different nursing groups throughout the state discussed with the Board the legislation that was passed in 2009 to license sonographers and radiology techs. A part of the legislation would require nurses, unlike other medical practitioners, to be licensed to use sonography or ionizing and non-ionizing radiation procedures. The bill had been drafted poorly and the Rules and Regulations are still being worked on and have not yet gone into effect. Were the rules to go into effect as the Act is written, it would require nurses to prove their education and training to the NM Environment Department Medical Imaging and Radiation Therapy Advisory Council (MIRTAC) and obtain approval prior to using ultrasound or any form of radiation. The nurses have asked the Medical Board for their support to be exempt from this Act. The Board of Nursing will go before the legislature in 2013 with the request to exempt nurses from this existing Act. Dr. Weiner MOVED that the New Mexico Medical Board support the exemption of nurses from the current requirements of the NM Environment Department Medical Imaging and Radiation Therapy Health and Safety Act. Dr. Jenkusky SECONDED YES: Dr. Weiner. Ms. Cochran, Mr. Bourbon, Dr. Kankanala, Dr. Kovnat, Dr. Miller, Dr. Komadina and Dr. Jenkusky. **MOTION PASSED.**
