8. REPORTS

- A. Chair Dr. Kovnat brought to the board's attention the ongoing concern of the board about the management of chronic pain. Dr. Daitz, Professor Emeritus and physician met with the board and discussed concerns that physicians and patients have in the treatment of chronic pain. Pain management is not being taught properly and there is a concern as to where a patient can go to receive treatment. If patients are unable to locate a pain management physician they will need to go to their primary care physician for such treatment. Many primary care physicians are concerned about the possibility of disciplinary action from the board if they over-prescribe for pain. Dr. Kovnat has requested that this issue be a focus of the February board meeting. He would like staff and a task force to work with the Federation of State Medical Boards and other specialists, possibly also setting up a conference in Santa Fe focusing on chronic pain management.
- B. Executive Director Ms. Hart informed the board that DFA announced we will not be required to cut our budget 5% for the remainder of this fiscal year, although there is a hiring freeze in effect. One budgetary item that had been reviewed for budget cuts was the physician roster book. She asked the board if there was a possibility that the annual roster be produced electronically versus a hard copy. Ms. Cochran MOVED to produce a hard copy of the book for 2009 with a notice announcing that it would be the last year it would be produced in book form. Future years would be electronic only. Mr. Ghadimi SECONDED the motion. YES: Dr. Kovnat, Mr. Ghadimi, Mr. Heim, Ms. Cochran, Dr. McRoberts, Dr. Giudice, Dr. Weiner, Dr. Crespin and Dr. Lauriello. MOTION CARRIED
- C. Medical Director No report at this time.
- D. Assistant Attorney General Ms. Buzzard reported on Dr. Knight's appeal order from the court. The court upheld the board's decision to deny his licensure, but reversed the decision that he could not reapply for five years. The judge explained that the board did not provide a basis or reason for not allowing him to reapply for five years. Dr. Knight has twenty days from October 31, 2008 to appeal this decision.
- E. Administrative Prosecutor Mr. Khalsa informed the board that there are currently three Notices of Contemplated Action that need to be issued and there are three hearings scheduled, one in November and two in December.

- F. Licensing Manager Ms. Quintana reported on the 2008 CME Audit Results. 209 licensees were randomly selected in the CME audit. Only one licensee has not responded to the request to provide the 75 hours of continuing medical education. Also, the final licensee renewal numbers for Fiscal Year 2008 were reported to the board.

 She reported that as of November 13th, 117 applicants have taken advantage of the new legislative incentive making New Mexico their first state for licensure and having the fee waived. The wording amending question #6 on the application and renewal form was then discussed. The board would like the words "expunged" and "sealed" added in the explanation of the question.
- G. Financial / HR Manager Ms. Mascarenas went over the budget report. She explained that every odd numbered fiscal year there is to be a 50% budget available as of December 31st in the event of a change in administration.
 The request has been submitted for the RFP process for a monitored treatment program. Dr. Kovnat, Dr. Lauriello, Lynn Hart, GTS Khalsa and JJ Walker are on the committee for the review. The tentative date of the contract award is February 9th with an effective date of July 1, 2009. The audit has been completed and an exit conference will be scheduled with the board chair and Ms. Hart before final approval of the board.

 the expansion of the definition of "psychotropic medication" and also a change in the nature of
 supervision during the 400 hour practicum. The board has requested that further discussion be held
 regarding these changes with the supervisory task force.

15. NEW BUSINESS

- A. Physician Assistant Presentation
 - Physician Assistant Schools Tom White, PA-C, Director of the Physician Assistant School at the University of New Mexico and Mr. Will Riesterer, PA-C, Director of the St. Francis

- Physician Assistant School, both located in Albuquerque, presented an outline of the operation of the two schools. In the course of discussion, they explained that more physicians and institutions were tending to hire independent mid-level practitioners, ie: nurse practitioners, because of the logistical difficulties with supervision in more remotely located clinics.
- 2009 Legislation The New Mexico Academy of Physician Assistants became aware of proposed legislation in 2009 that will address this issue, specifically exempting certain groups of PA's from the current requirements for primary and backup supervision by physicians. The Legislative Council Service is drafting a proposed bill, but at this time the board is not comfortable making a decision on this legislation, therefore requested further study and additional information be presented to them at their January meeting.
- B. 2009 Legislative Session No further legislative issues were discussed.
