Information on Federal Grant Announcements, Including New Mexico

Ms. Frank reported to the Board that HHS awarded \$53 million in funding to many states in an effort to reduce opioid related death and strengthen drug misuse prevention.

Ms. Frank stated that NM DOH, HHS and OMI received a large portion of the money, which is largely being used to study the various reasons why opiates have become such a problem. Specifically, HHS wants to do a survey of the Boards licensees regarding the PMP, basically asking what the pros and cons of the PMP and are licensees actually reviewing the PMP when it's pulled or just putting it in the medical record never to be seen again. OMI has put together data of overdose death data which is also being studied by staff. Part of this grant money is going to go toward getting us better information, the information we currently receive is not that helpful.

13. New Business

Chiropractic Board presentation regarding proposed formulary rule change.

Dr. Michael Pendleton and Dr. Kathy Reichman presented the proposed formulary rule change to the Board for their required approval. Dr. Reichman stated that the addition of the medicines to the formulary would help with patient outcomes. Dr. Pendleton stated that the Pharmacy Board said they would like to have all three boards meet together prior to any decision being made. Nalaxone was added to the formulary because they have a lot of chronic pain patients and seekers, but mostly in case of a rescue situation. It was reported that very few chiropractors prescribe at all. A masters was required for prescribing however there is no masters program at this point, so they are currently requiring the 75 to 90 hours of training. Side effects from hormone replacement therapy would be referred out. It was also mentioned that there is a philosophical tension between homeopathic physicians and chiropractors. Dr. Pendleton and Dr. Reichman would like to see the boards work

together for the safety of the patient. The next step of review and approval of the formulary is to form a subcommittee of the Pharmacy Board, Medical Board and Chiropractic Board.

Pharmacist protocol for prescribing oral contraception

Dale Tinker director of the NM Pharmacist Association, Amy Backris, PharmD and instructor for pharmacist training programs, Lauren Thaxton, MD and Dianna Koster, MD presented the protocol for prescribing oral contraception and addressed the public health issue of unintended pregnancies and access to birth control.

The protocol was developed for easier accessibility. Fifty-five percent of pregnancies in New Mexico were unintended. Many individuals experience barriers associated with obtaining a prescription for contraception, including lack of family planning providers in rural communities, difficulty scheduling and attending appointments and gaps in contraceptive use associated with running out of refills. A Pharmacist's ability to prescribe contraception could eliminate the need for a separate medical visit and improve access for many individuals.

The presenters assured the Board that physicians would continue to play a critical role in the patients' reproductive and general healthcare. The protocol requires pharmacists to refer patients to their primary care providers or local clinic if they have medical risk factors that make them ineligible under the protocol, are experiencing side effects, or are seeking methods not provided at the pharmacy.

The presenters stated pharmacists would really want to do this because of the extensive training. The protocol outlines the USMEC (part of the CDC) which is considered the gold standard. The other guidance given to the patient would be education regarding STD's, get the patient started with a regular ObGyn. Dr. Koster stated that the eagerness of the pharmacists is refreshing. She reiterated that access is the number one issue. You need a history and blood pressure and a fee, and a woman can walk out with birth control. New Mexico citizens are impacted by the shortage of providers especially in rural communities. The protocol will expand the access to care and the key here is access afterhours and on weekends.

The Department of Health has been involved in the development of the protocol and the education and training.

Dr. Komadina stated that this has been very well thought out. He does not see too much trouble and he is very supportive of this. He hopes that it gets used.

Ms. Frank reported to the Board that we received two more PMP Report Cards for the First Quarter of 2016. One of the reports had 241 practitioners listed who had never pulled a PMP. Staff sent letters to each of the licensees requesting response as to why they had not pulled any PMP's. As of 11/17/16 we have received 179 written responses and are still waiting on 62 to respond. If no response is received they will be forwarded to Investigations. Mostly the responses have been very positive. It was proposed to ask the Hospital Association and the Medical Society to post our new rules regarding opiate prescribing.

Revenues collected from July 1, 2016 through September 30, 2016 total \$264.9 (or 14.79%) of budgeted revenues. The agency also budgeted \$100.0 FB in FY17.

The Cash Balance as of November 18, 2016 is \$722,730.85.

The balance incudes the reduction of \$500.00 fund balance sweep to DFA general fund reserve, Per L16, 2SS, SB2, C4, S003-A-036. Funds were transferred to DFA via operating transfer on 11/15/2016.
