# Financial / HR Manager

FY18 Budget/Revenue Status

- Expenditures total \$433,000 (or 22.79%) of budgeted expenditures from July 1, 2017 thru September 30, 2017 (Opbud \$1,900,000);
- Revenues collected from July 1, 2017 through September 30, 2017 total \$300,600 (or 16.52%) of budgeted revenues in the amount of \$1,820,000. The agency also budgeted \$80,000 FB in FY18.
- The Fund Balance on June 30, 2017 is \$772,654. The Fund Balance in FY18 as of October 31, 2017 is \$453,091. (This figure consists of Fund Balance on June 30, 2017 plus revenues received from 7/1/17 10/31/17 less expenditures from 7/1/17 10/31/17).
- The Cash Balance in FY18 as of October 31, 2017 is (\$235,235). (This figure consists of Revenues received from July 1, 2017 October 31, 2017 \$334,693 less expenditures for the same period \$569,928 resulting in a negative Cash Balance of (\$235,235).
- The FY18 Statistics Summary reflects the application/renewal and other fees data that makes up the total revenue received in FY18 beginning on July 1, 2017 through September 30, 2017 of \$300,600.
- The NMMB's audit was performed in September, 2017 by Robert J. Rivera, CPA, PC, and was due to the State Auditor's Office by November 1, 2017. The audit exit meeting was held on October 26, 2017 with Ms. Frank and Ms. Mascarenas. No audit findings were reported for FY17. Mr. Rivera contacted Dr. Jenkusky on November 1, 2017 and conducted an exit audit with him via telephone. After the audit has been released from the State Auditor's Office the Board will need to vote to approve the 2017 Financial Audit at the next Full Board Meeting.

## **FY19 Appropriation Request**

 The FY19 Appropriation Request for the NM Medical Board was presented to the House Appropriations Finance Committee (HAFC) on October 25, 2017, Ms. Frank and Ms. Mascarenas attended the hearing.

The increase, primarily in personal services and employee benefits, is to utilize funding for the second half of the Medical Director position to fund a part-time Toxicologist/Epidemiologist to assist with the Board's injudicious prescribing cases.

#### **Chair Report**

Dr. Jenkusky reported that he and Ms. Frank were asked to attend the NM Medical Society (NMMS) Meeting on October 14, 2017 to discuss the issue of medical histories obtained from licensing applicants during the application process that further the stigma of mental illness and discourage physicians from seeking treatment for mental health issues. After that meeting the NMMS submitted a Resolution to the Board for consideration to work with them to change the wording in the Board's Professional Practice Question number 18, which currently asks:

"In the five (5) years prior to this application, have you had any physical injury or disease, or mental illness or impairment, which you are currently under treatment for or could reasonably be expected to affect your on-going ability to practice medicine safely and competently? If yes, please have your treating physician send the NM Medical Board a letter regarding your diagnosis and treatment."

Dr. Jenkusky invited Heather Brislen, MD and Eileen Barrett, MD to further discuss the issue. They stated that NM has been recently affected by the tragedy of physician suicide and are looking for ways to better support their physician colleagues and create a healthier environment in which to practice medicine. Dr. Brislen and Dr. Barrett referenced the AMA which has "...urged state medical boards to refrain from asking applicants about past history of mental health or substance use disorder diagnosis and only focus on current impairment by mental illness or addiction, and to accept "safe haven" non-reporting for physicians seeking licensure or re-licensure who are undergoing treatment for mental health or addiction issues." They went on to discuss the different recommendations from The American Psychiatric Association, the Federation of State Medical Boards and the Mayo Clinic.

Dr. Brislen and Dr. Barrett suggest rephrasing question 18 to ask "**Do you have** any physical injury or disease, or mental illness or impairment, which you are currently under treatment for that could reasonably be expected to affect your on-going ability to practice medicine safely and competently? **If yes, please have your treating physician send the NM Medical Board a letter regarding your diagnosis and treatment.**"

They stated that this change would encourage the wellbeing of physicians and trainees, and would ultimately be good for protecting patients too.

The Board stated that they would look into this further and possibly do some outreach to medical students and residents explaining the licensing process and the Board's intention to help and facilitate treatment for physicians in need.

## 12. New Business

## Qualifications of the Chairman Limited to MD's -

Dr. Beaudette reported to the Board that he thinks the position of Chairman should be held by a medical physician for a couple of reasons, it's a medical board with 8,000 MD's and 700 PA's, and our number one obligation is of course to protect the public but another goal the Board has is to support physicians who need support in practice and to keep them in practice. MD's have a better insight into these goals. He also thinks in medicine MD's are losing more and more of their autonomy. Dr. Beaudette also stated that the public perception is very important, and the New Mexico Medical Board needs to have an MD on the letterhead and sign the Board's letters. He stated that the Medical Society also recommends this. The Board discussed this issue at length and decided to wait for a final decision about voting for a policy until all Board Members are present.

## **Opioid Epidemic Update**

Mr. Bourbon reported on the opiate crisis and various reports that have come out. The fact is that there are some legislative barriers that are holding back the efforts to gain control of the epidemic. There is a lot of Federal Money being given to states including New Mexico, he feels that some of that money should be used toward promoting the public health portion of the Narcan Program.

#### Dale Tinker – Naloxone and pharmacist's reimbursement issues.

Mr. Tinker reported to the Board that pharmacists do not receive reimbursement for Noloxone and Narcan. Narcan is FDA approved and is much easier to use but they don't reimburse for clinical services. They are being underpaid for the product. Also, at this point pharmacies are having trouble getting the nasal adapters for Noloxone. There is a shortage of products. Fifty percent of pharmacies are now stocking Noloxone, however they are starting to not dispense it because they are losing money because they are not getting reimbursed.

# **Suboxone Waiver Modification for PA/RN**

Mr. Bourbon reported that the Comprehensive Addiction and Recovery Act (CARA) was put into law in July 2017 which addresses the full continuum of care from primary prevention to recovery support, including significant changes to expand access to addiction treatment services and overdose reversal medications. Specifically, Mr. Bourbon wanted to bring to the attention of the Board that the Substance Abuse and Mental Health Services Administration has indicated that if collaboration or supervision is required by state law it will interpret CARA in such a way that NPs and PAs will not be required to collaborate with or be supervised by a waivered physician as a condition of their own waiver, as long as they and their associated physician otherwise meet the requirements of the program. The ASAM, AANP, and AAPA are urging regulators to follow this approach.

# **NM Cannabis Program**

Mr. Bourbon stated that currently there are 50,000 active cards in NM. Currently there are 20 qualifying conditions. They are trying to add more qualifying conditions including eczima, diabetes and encephalopathy. The Board briefly discussed the statistics presented.

# Medical Cannabis Dispensary within Physician Owned Pain Clinic.

Ms. Frank briefly explained that James Rice, MD wanted to present to the Board an approach to combine and established medical practice with a Medical Cannabis Dispensary to improve patient care for chronic pain patients. Ms. Frank reported that Dr. Rice was unable to attend the meeting and was hoping to table this issue until he is able to attend.

The Board determined that a task force will be convened and will report recommendations back to the Board.
