Approval of new language for Professional Practice Question #15 on the NMMB application for

licensure.

The Board reviewed the language for Professional Practice Question #15. After much discussion, the Board agreed to revise the following aspects of the question and to bring the revised question back for further discussion and revision at the November 2025 full Board meeting.

- Changes will reflect the following:

Remove 5 years and replace with 3 years and the term, "that". Question #15 will now read, In the past 3 years have you been mandatorily enrolled in a Physician Health Program, or have you been told that to maintain your license you must enroll in PHP?
