Richard Romero gave a recap of the activities that he has been involved in within the last quarter and let the Board know that he attended several interim committee meetings including Legislative Finance Committee Meeting, Health and Human Services Committee Meeting, Rural Economic Development Committee Meeting and the Hearts and Corrections Committee Meeting. Mr. Romero scheduled a meeting with the Senator Sedillo-Lopez, Dr. Jenkusky and PA Johnson to discuss the proposed legislation. Mr. Romero finished his report with informing the Board of specific legislative facts regarding the changes and movement within the House and Senate branches in the New Mexico legislature.

9. <u>New Business:</u> <u>New Mexico Medical Society</u>

Annie Jung, Executive Director, Nick Autio JD, General Counsel and Carrie Robin Brunder, Legislative Liaison, spoke about how Scope Expansion is aiming to expand the scope of various health care professionals to be able to perform health care services that have traditionally been performed by physicians. NM has a medical workforce shortage – that is one of the key things that NMMS works on. They are targeted on retention and recruitment. Their goal is to keep the doctors that work in the state of NM here and working to their full potential. They are also focusing on patient needs continuing to grow and are focusing on meeting those needs.

Timely access to quality healthcare is another main priority of the NMMS. They are working to hold policies to maintain physicians as the leader of the healthcare team in the interest of high standards of quality care and patient safety. With Scope Expansion request, this puts the regulatory boards to determine who is sufficiently trained to expand their scope of what they can do to treat patients beyond schooling and training to aim toward the goal of increasing healthcare access in rural areas in New Mexico.

In studying the issue, they have found that the defining difference between physicians and other medical professionals is the requirement for a residency and believe this is extremely crucial. They also spoke about the Board's role in education, training and experience when licensing.

NMMS stated that they believe the NMMB plays important roles in Scope Expansion discussion:

- Advisory role with the NM Legislature it is crucial to let legislators know what Sope Expansion is and how it relates to patient safety and access to care
- Regulatory role if a law is passed, it is the responsibility of the NMMB to develop regulations to implement and enforce laws.

NMMS concluded their presentation with speaking about working heavily with the legislature to advance policies to enhance policies to improve the professional environment for physicians and medical teams. They also informed the Board about legislative priorities and agenda with specifics on legislative information related to Scope Expansion and how it generally applies to patients and the healthcare system in New Mexico and how they are looking at solving the workforce shortage through legislation.

Think New Mexico

Fred Nathan Jr., Executive Director, Kristina G. Fisher, Associate Director, Alfredo Vigil M.D., Healthcare Reform Director, Katie Gutierrez, Tax, Budget, and Economic Development Reform Director, spoke about what Think New Mexico is and what their goals are around serving New Mexicans through solutions over political ideology. In early 2024 Think New Mexico put out a report on solving the healthcare worker shortage with 10 major recommendations.

Think New Mexico focused on speaking about the Compact for Doctors and how they envision mirroring Colorado's model of being in all 10 Compacts here in NM. The NMMB gave their comments and questions first regarding the concerns around joining the Compact and the concerns around licensing the individuals within the Compact system pertaining to different licensure requirements while stating that the priority is to keep all patients safe.

The topics of abortion, rural community healthcare access, and graduation/ training requirements (IMG & FTP) for applicants all around the world. NMMB re-stated that they are keeping the safety of New Mexican patients as the main priority.

d. <u>Medical Director</u>

Review and Approval of Agency Guidelines for:

<u>A.I.</u>

Dr. Carson spoke about the policy that had been sent out regarding A.I. There were several concerns from the NMMB around the policy pertaining to HIPA and Duty to Disclose to Patients. Dr. Carson addressed and stated that the information around the concerns is found areas that were already incorporated into the policy. Dr. Richards brought up a topic of staying away from being any more prescriptive than what is already in the policy. Dr. Carson spoke about all areas that A.I. is currently

being used and noted that the goal is to keep the policy as non-specific as possible but to make sure follow the basic ethic guidelines of medicine.

IV Therapy

Dr. Jenkusky spoke about how this topic came to his attention. He informed the Board about the information that he shared with the NM Board of Nursing and let the NMMB know that they clearly see it as the practice of medicine and should be done only with an assessment and doctor's order. Dr. Jenkusky wrote additional guidelines and had them reviewed by Board of Pharmacy and the Board of Nursing Directors to address the issue that it should be only falling under the practice of medicine and that all guidelines with practicing medicine are applicable. Dr. Jenkusky asked the NMMB to review the policy to consider posting on the NMMB website. There were a few notes and concerns brough up by the NMMB that Dr. Jenkusky addressed by mentioning the practice of medicine and expertise when looking at these topics. Dr. Carson and the NMMB made the final suggestion for the policy to include more direct information that clinical care sights MUST adhere to appropriate rules regulations and guidelines and stated that it will go to vote.

Prescribing Psychologists

Dr. Jenkusky stated that this topic will not need a vote as it was only informational. He provided the history on this topic including speaking about the timeframe that this has been around and where this is happening here in New Mexico. Dr. Jenkusky let the NMMB know that they may see the request for the Prescribing Psychologists to be under the NMMB. The NMMB has been tasked with working directly with this group as a committee on a training protocol, possible practicum and other topics that arise when looking at getting this going. Dr. Carson asked if there were any Board Members that were interested in working with this group and Dr. Scoggins volunteered to assist. It was talked out that both the NMMB and the Phycologist Licensing Board will need to be involved in this project.

And "All clinical care sites must adhere to appropriate pharmacy rules, regulations and guidelines.". **SECONDED**, Dr. Unverzagt. **YES**, Dr. Carson, Dr. Unverzagt, PA Johnson, Dr. Reidy, Dr. Scoggins, Ms. Daniels, Dr. Roth, Dr. Richards. **EXCUSED**, Dr. Barrett. **MOTION CARRIED**.

- ✓ From July 1, 2024 through September 30, 2024 expenditures total *\$519,174.24 (or 14.7%)* of budgeted expenditures (Opbud \$3,525,300).
- ✓ From July 1, 2024 through September 30, 2024 the agency collected revenues in the amount of *\$453,397 (or 14.9%)* of budgeted revenues (Opbud \$3,045,300; FB \$480,000 = \$3,525,300).
