Friday, May 15, 2026

Dr. Carson, after establishing the presence of a quorum, called the May 15, 2026, Regular Board Meeting of the New Mexico Medical Board to order at 8:33 a.m., roll call was completed.

9. REPORTS

Executive Director

Interim Executive Director Monique Parks informed the Board that the New Mexico Medical Board has hired Letitia Mee as Licensing Administrator and Mattie Duran as Licensing Specialist. In addition, the Board has hired three contract employees, two of whom will assist the Licensing Department and one who will assist the CFO. Despite these recent hires, two vacancies remain within the Licensing Department, with interviews scheduled for one of the positions next week. Ms. Parks stated she is hopeful that all positions will be filled by the end of June.

Ms. Parks stated that the investigations team worked really hard to bring the caseload they did to this meeting and currently has an outstanding caseload of 255 cases pending. She also stated that there have been two new hires in the investigations unit and is hopeful that this will help with the caseload. Ms. Parks also touched on a certification course through AIM that she is looking into sending all investigators to.

Ms. Monique Parks also informed the Board that she and Samantha Breen, Licensing Manager met with the FBI regarding an audit, and based on feedback received, the Federal Bureau of Investigation indicated the audit was successful and that the agency is following the required rules and procedures. Ms. Parks also reported that Dr. Shields and she met with RLD, the

Cosmetology Board, Nursing Board, and Board of Pharmacy regarding Med Spas, which Dr. Shields will address further during his report.

Ms. Monique Parks informed the Board that staff have drafted the proposed rules regarding the IMLC and will begin meeting with the Rules Committee next week. Ms. Parks further advised that complaint committee assignments will be reassigned following the meeting, with updated assignments to be distributed next week. Ms. Parks also reported that Ms. Medrano contacted another state facility in Albuquerque regarding office space or Hoteling accommodations, and a cubicle may be available for use by commuting staff on a rotating basis. In addition, the Board is considering changing public office hours from 8:00 a.m. to 4:00 p.m., which would require a policy change.

Chair Report

Dr. Carson, Board Chair provided the Board with a Year-End Summary which summarized various topics including legislative advocacy efforts during the 2026 session, noting significant healthcare-related legislation and anticipated proposals for the 2027 session. Key items included the telemedicine registry bill (HB0127), foreign-trained physician licensure pathways, Physician Assistant independent practice legislation (HB0150), implementation of the Interstate Medical Licensure Compact (IMLC), medical malpractice reporting and statutory considerations, and scope of practice legislation. Dr. Carson also mentioned the ongoing efforts to increase budgetary funding to expand investigations, improve transparency, enhance rehabilitation programs, and strengthen education and public outreach.

Within the Year-End Summary, Dr. Carson also highlighted key initiatives and discussions from the 9/26/25 Board retreat, including the formation of working groups and committees on telemedicine, artificial intelligence, foreign-trained physicians, disciplinary guidelines, policies, and scope of practice. Additional focus areas included clinician wellness initiatives, licensing application revisions in partnership with the Dr. Lorna Breene Foundation, alternative licensure pathways, personnel needs including executive leadership and management positions, data infrastructure improvements for complaint tracking, public education and outreach, and nutrition CME requirements under the Rural Health Transformation Program Grant.

Dr. Carson made note of the continued work on data analytics infrastructure and that everything is going well. She also noted the work being done on each Executive Committee monthly case review meetings and stated that the committees have been working on malpractice review and application review. Dr. Carson then noted the links within the Year-En Summary to the issuance of complaint guidance materials for licensees, and ongoing legislative and professional presentations and gave a brief explanation of each.

Dr. Carson informed the Board of the upcoming staff structure change that will be happening in the near future. This will include moving the entire Licensing department staff, which is currently managed by the CFO, to the management of the Interim Executive Director, and what the logistics of that will look like as the changes are made. Dr. Carson also mentioned that she is

hoping to request from legislation that NMMB have an increase in Board members including more public members and possibly a legislative appointee. Ms. Medrano also noted to the Board that there might be another option to obtain more Board members, and that being to require a representative from a sister agency to serve on the Board. She stated that some other state agencies have medical personnel that may be able to serve on the Board without having to be an appointee.

Finally, Dr. Carson opened the discussion to the Board regarding any updates or information brought back from the FSMB conference. Dr. Barrett and Dr. Unverzagt spoke on various topics that were covered during the course of the conference including learning opportunities around the conversation of AI, Quality Assurance, Crisis Communications, Safety Sensitive Positions and Committee Organization noting some information they found to be useful and possibly applicable to NMMB's policies and procedures.

Management Consultant **Board Attorney Report**

OPEN SESSION

The Board returned to open session. Dr. Carson stated for the record that the matters discussed in executive session were limited only to those specified in the motion for closure.

Medical Director

Dr. Shields, NMMB Medical Director, reported to the Board that New Mexico has seen rapid growth in medical spas and wellness clinics offering medical and cosmetic procedures, leading to regulatory and safety concerns noting that some major issues include:

- Unclear supervision structures and minimal physician involvement
- Delegation of medical procedures to unlicensed personnel (e.g., medical assistants, aestheticians)
- Risks associated with laser and energy-based procedures (e.g., burns, improper training)
- Concerns with peptide therapy, GLP-1 clinics, and telemedicine models, including online prescribing and lack of oversight
- Public confusion due to misleading marketing and unclear credentials

Dr. Shields additionally notes that there are also concerns about ownership structures where non-physicians exert medical decision-making influence.

NMMB and multiple other New Mexico regulatory boards recently met to discuss these challenges and proposed next steps such as unified guidance, policy revisions, public education, and increased enforcement. Finally, Dr. Shields emphasizes the need for ongoing interagency collaboration to ensure patient safety and clarify lawful practice boundaries in this evolving field and stood for questions and comments from the Board.

Licensing Manager

Licensing Manager, Samantha Breen provided the Board with the following licensing statistics and answered questions from the Board.

Finance

Lusan Leyba, NMMB CFO, reported to the Board on the following topics:

- The budget revenue status ending March 31, 2026:
 - From July 1, 2025-March 31, 2026, expenditures total \$2,268,860.29 (62.96%) of budget expenditures (Opbud \$3,603,400).
 - From July 1, 2025, through March 31, 2026, the agency collected revenues in the amount of \$1,104,444.33 (32.94%) of budgeted revenues (Opbud \$ 3,353,400.00 FB \$250,000=\$3,603,400.00).

- Discussed the FY27 Legislative Finance Committee Hearings that were held on January 13, 2026:
 - Agency requested a budget of \$4,090,700.00 and the LFC recommendation came in at \$3,981,600.00 which was \$109,100.00 less than what the agency requested. The \$109,100.00 was a decrease in salaries due to the vacancy rate.
 - FY27 Operating Budget was presented and voted on in the amount of \$3,996,900.00 which includes the 1% salary increase in FY27.

Drexel Physician Reentry Program, Nielufar Varjavand, MD; Professor of Medicine, Drexel University

Nielufar Varjavand, MD; Professor of Medicine, explained to the Board what the program structure looks like for physicians entering back into the medical field through the Drexel Physician Reentry Program. She covered various topics throughout the presentation including why physicians initially leave the medical field, what may possibly bring a physician back into the field, gave background information on how the program started, statistics of Board policies on reentry, information on the Federation's reentry to practice requirements, research conducted by Drexel University and a step by step explanation of how the Reentry Program operates.

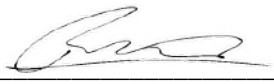
